April 14, 2020 - Call for Entrees March meeting June 16, 2020 – Complete Entry, pay fee, submit art.

Enter with your photos of 2D and 3D art. All entrees must be submitted with **art on disc or flash drive**.

Also, **Liability Form for Holland Gallery** must be submitted. See website for all forms.

Panel of Judges to determine accepted works. See Rules & Regulations form on website.

June 30, 2020 - Notify artists of paintings accepted.

Installation: September 24, 2020 • 9am - 1pm

Reception: October 9th 2020 • 4:30 - 6:30

Take Down: October 29, 8 am – 10 am

The show is open to all members of MAL at time of entry submission and date of show. Entries must be original artwork created by the member and completed within the past three years (of date of entry). Two-dimensional traditional works may be entered in any medium (oil, acrylic, watercolor, mixed media, charcoal, graphite, pastel, etc.). 3D works of art must be able to stand on pedestals or in shadow box frames (eg. Jewelry) for safety of art. Artwork must be marked NFS or priced to consider the 20% commission taken by Holland Gallery.

Artwork created in workshops or under the supervision of an instructor is not eligible. Computer generated artwork or work based on copyrighted photos or digital creations are not eligible for this competition.

Works must be properly framed. Gallery wrapped canvas must have **painted/finished sides** that are clean and undamaged. Wood cradled canvases must have clean, undamaged, and finished-looking sides. Gallery wrapped and wood cradled canvases must be at least 1.25' in depth. Must have eye screws (preferably D-rings), wired and ready for hanging. **No sawtoothed hangers allowed.**

Mats must be neutral in color, clean, and professional in appearance.

All artwork must be labeled on the back with artist name, title, medium, and price.

Gallery Requirements:

- Works submitted for exhibit must be for sale or marked NFS.
- The artist grants Holland Gallery the right to sell the work(s) of art.
- A sales commission of 20% will be retained by Holland on all sales.
- Work must remain hanging for the duration of the exhibition.
- Holland Gallery will handle all sales. So, price your work with this in mind.

Prizes: Prizes to be announced at reception. According to the number of entries received.

Holland Gallery, MAL, or any of their representatives will not be held liable for any damages, loss, theft, or injury which may occur during any/all activities. MAL reserves the right to refuse any/all work. Signing this

release means you approve of the use of your artwork for Holland Gallery/MAL publications and promotional material. MAL will not be responsible for damages to or loss of submission materials. I also understand that should any of accepted art on exhibit be sold through Holland Gallery, a 20% commission will be withheld. MAL will not take a commission.

Holland Gallery Hold Harmless and Liability form must be signed by each artist.

2. To enter by mail, submit entry form, CD or flash drive with images and appropriate fees MAL. Include your **PayPal Confirmation** number. Transmit artwork thru **www.WeTransfer.com**

Submission Guidelines:

1. Entry Fee: \$45.00 for up to 4 works.
2. Submit a JPG for each piece at 300 dpi, file size approx., 400-500 kb or 1000 pixels maximum on the longest side. Each image must be labeled with the your first initial, last name, title of piece. eg. **JSmith, Portrait of John Smith.jpg!!!! Be sure to name artwork photos!**
3. Images should be cropped to exclude extraneous backs or frames and adjusted for color correctness and quality. Jurying is done from your images. Poor quality photography or improper preparation may result in disqualification. CDs will not be returned. Prints or slides will not be accepted. If accepted work does not abide by the rules set in the prospectus or is not the quality shown in the photo, the MAL has the right to refuse entry into show.
4. To enter by mail, submit entry form, CD or flash drive with images and appropriate fees MAL. Include your **PayPal Confirmation** number. Transmit artwork thru **www.WeTransfer.com**
5. You must provide a working **e-mail address** in order to receive notification of acceptance.
6. Only members may enter. You may join MAL prior to or with your entry.
