



## Art Shows/Exhibits/Venues Rules & Regulations

Entries not complying with these rules may be refused.

Mesa Art League embraces art of photography, metal, glass, digital, airbrush, oils, acrylics, watercolor, flow mediums, colored pencil, pastels, ink, mixed media, abstracts, sculptures, clay, pottery, illustrations, and more. As all art types merge together for shows, individuals are encouraged to look closely at other artists techniques and purity of their arts discipline.

**These rules shall apply to all MAL Juried art shows, to the Artwork of the Month contest, and to all hanging venues of the MAL. Exceptions for venue exhibits are noted.**

### **BE ORIGINAL! All works must be the artist's original concept, design and execution**

Such images may be used for publicity and/or promotional purposes without any rights to the artist for remuneration. MAL will only use the images of the entered artwork for those purposes.
