Discussion and/or Approval of Village Board Meeting Minutes from March 5, 2025

A motion was made by Trustee Place to approve the Village Board Meeting Minutes from March 5, 2025, seconded by Trustee Coley. Motion carried unanimously.

Review and Approve Agenda

A motion was made by Trustee Coley to correct agenda item 9 and strike out Crime Information Bureau (CIB) Technical Security Questionnaire, as it was a typing error. Also, to table 6g and approve the rest of the agenda as Written, seconded by Trustee Place. Motion carried unanimously.

Review and Approve Easement for Fiber Optics Installation on Village Property

Public Works Report

Discussion Regarding Combined Sewer on S Washington Street

The Board will not be taking any action. If any issues occur the 2 property owners must deal with it. If they want to bring it up to code, they must provide the paperwork required to install the sewer lateral.

Discussion Regarding Preconstruction Meeting for the WWTP

Gene Churchill reported that at the WWTP Olympic is building the tanks that they had started on earlier. Winona is cleaning up the areas they worked on for the collection systems, they laid grass matting down so we should see grass growing soon.

Review and Approve Change Order for Additional Sludge Storage Tank Panel Regarding the WWTP Project

A motion was made by Trustee Coley to Approve Change Order for Additional Sludge Storage Tank Panel Regarding the WWTP Project, seconded by Trustee Place. Motion carried unanimously.

Review and Approve Wolter Inc.'s Preventive Maintenance Program

A motion was made by Trustee Coley to Approve Wolter Inc.'s Preventive Maintenance Program for the Annual Full-Service w/Inspection for all 4 sites in the total amount of \$4598, seconded by Trustee Place. Motion carried unanimously.

<u>Discussion Regarding Annual Cleaning and Televising Sewer Collection System</u>

Steve explained that every year they do this cleaning and televising to prevent backups in particular sections.

Police Chief Report

Clerk Klein reported on behalf of Police Chief. There was a car at the apartment buildings that was repossessed. He also asked the Board to contact him if there are any questions regarding the Crime Information Bureau (CIB) Technical Security Questionnaire.

Fire Chief Report

Fire Chief Madland reported that in the last 31 days of March there were 28 calls between Fire and EMS. He provided Clerk Klein with invoices and payments.

A motion was made by Trustee Coley to Approve Purchase of 2 Sets of Turn Out Gear for the Fire Department in the amount of \$6088, if it goes over this the Fire Department Fundraiser will pay the difference, seconded by Trustee Place. Motion carried unanimously.

Jeff Scully suggested for Village to ask for an easement from Alliant to be able to dump snow in the area in the Industrial Park. It was asked if our street sweeper was broken. Vets Memorial Park clean-up is Saturday April 26th, starting at 9:00am. Rep from Kalen Property Management asking about putting in a campground and what are the rules/ordinances in doing so. It is currently zoned residential and there is no Village infrastructure there for Water and Sewer. There is a section in our ordinances that allow areas such as this to put in their own septic.
