Agreement to Our Legal Terms

We are Mass Island Corp ("Company," "we," "us," "our"), a company registered at **854 Lexington St, Waltham, MA 02452, United States**. We operate the website <https://massisland.org/> (the "Site"), as well as any other related products and services that refer or link to these legal terms (the "Legal Terms") (collectively, the "Services").

These Legal Terms constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you"), and Mass Island Corp, concerning your access to and use of the Services.
