- May play after 1:00pm on Saturday & Sunday. May only book after the lottery has been run on Thursday at 1:00pm
- \$500 spending minimum. Spending minimum must be spent annually between March 1st and February 28th. Any remaining balance will be invoiced
- Unused rounds cannot be transferred or carried forward
- Social membership issued to designated individuals. May have up to 4 designated Individuals on the membership
- Corporate membership applicants must have a valid business number that can be verified by the Canadian Revenue Agency

Membership Round Information

- Rounds are non-transferable and subject to HST.
- Members must report to the Proshop prior to their round.
- Member may request upgrade to a higher level once during the season. Will be subject to availability of space within the level cap.
- Member rounds must be used in the season issued. No rounds will be carried forward to the next year. No refunds will be given for unused rounds. Rounds are non-transferable
- Membership round holders may play nine holes. Nine holes will be considered a half round. (Members playing the front 8 holes or the back 10 holes only will be considered half round) Should a Member play a hole on the back nine they will be considered to have played 18 holes (a full round).
- Round holder is subject to Club spending minimums.
- Memberships in all categories will be capped.

Tournament Eligibility

- Full Playing, Intermediates, Member 30, Member 20 and Life are eligible to play in all Club Tournaments and Interclub Competitions.
- Member 30, Member 20 and Intermediate 20 must use one of their membership rounds for the tournament and must pay the tournament entrance fee.
- Playing 10, all Century and Family 20 are not eligible to play in Club Championships or Interclub team events. These members may play in Ladies Blast-Off, Jim Wilks, Parent & Child, Junior/Senior Mixed Two Ball, Cross Country Par 3, and Fall Freeze. The member must use one of their membership rounds for each tournament round played and must pay the tournament entry fee.
- All members must have a valid Golf Canada handicap to play in tournaments.

Guest Privileges

- Must play with a Brightwood Member and can play a maximum of 3 times per year only
- Tee Times for Guests are restricted to after 1:00pm on Weekends and Holidays; no restrictions throughout the Weekdays only when playing with a Member

All Member and Guest privileges are subject to review and amendment
