2. By accepting your application and deposit, Brightwood G&CC does **NOT** guarantee an offer of membership for 2023. We guarantee your spot on the waitlist only.
3. **Deposits are strictly non-refundable and will be applied against membership dues only, with no limitation of wait-time.**
4. You will be advised of your position on the waitlist within two weeks of your deposit being received.
5. A maximum number of wait list applicants will be determined per member category. If we are oversubscribed in a category (processed in the order applications are received), we will return your application and deposit.
6. Membership places will be offered in the order of the waitlist, subject to our rules of membership prioritization and the availability of spots in the membership category applied for.
7. If you are offered the membership spot you requested on your application and you decline the position; you will be removed from the waitlist and your deposit forfeited.
8. If we are unable to offer you your preferred membership choice as indicated on your application form, but we offer you an alternative membership category, which you decline, you **will not lose** your position on the wait list and your deposit will remain active.
9. Upon approval of your waitlist application; you will receive a complimentary round of golf to be used during the remainder of the 2022 golf season. You are welcome to bring guest/s during your visit, who will be charged at the member/guest rate only.
10. Should we be unable to offer you a membership spot in 2023, you will retain your priority position on the waitlist for 2024 and you will receive an additional TWO complimentary rounds of golf for the 2023 season.
