We address you today regarding your failure to protect the fundamental rights of Arkansans in this great state.

We the people of Arkansas have called, emailed, protested, shown up to school board and council meetings and committee hearings. We have filed a Writ of Mandamus, with affidavits attached in support, to compel you to honor your oath. With one voice, we demanded that you preserve and protect our freedoms by adhering to your oaths of office. You have been offered ample opportunities to address these issues, yet you stood by while an inept governor, a tyrannical Legislature, overreaching mayors, fascist city councils and county commissioners, courts, and an unaccountable federal leviathan destroyed our state.

We demand that you answer for your inaction, or we will continue to utilize all forms of communication to call attention to your failures and promote your impending removals from office. We have determined that if you are not standing up for our freedoms, you are part of the problem.

You stood by while tyrants attacked our most basic rights to live and work freely, using fear and tyranny to lock us in our homes and attack our rights to bodily autonomy.

You stood by while the National School Board Association (NSBA) branded parents who were exercising their rights by protecting and standing up for their children's rights when addressing elected school boards, which are implementing radicalized political agendas and unlawful mandates in the classrooms, a "form of domestic terrorism".

You stood by while Biden admin gave a post to National School Boards Association chief who signed 'domestic terrorism' letter.

You stood by while our energy grid was taken over by foreign companies, watched as our independent energy sources were sold or shut down, and stood by while Level 4 Bioweapon labs were opened in America's cattle and agricultural beltway.

You stood by while enormous outside forces were allowed to dribble millions into our state elections.

You stood by while our basic God-given and Constitutional rights were taken. You stood by while those in office, public servants, profited to become millionaires and billionaires. You stood by while special interest bills became laws, serving the few.

You stood by while the lockdowns closed many small businesses forever.

You stood by while countless elected officials who swore to uphold our Constitution treated Arkansans condescendingly because they dared to question the selected sample audits and addressed the lack of scrutiny over funds poured into the State by outside sources like Zuckerberg and the absolutely, clear-as-day, security issues in the November 3, 2020 election.

You stood by as the border was erased and our country was disseminated. You stood by as votes were stolen by uncertified machines. You watched as thousands of acres of Arkansas farmland was sold to Bill Gates and foreign communist genocidal countries.

You stood by while our school children were indoctrinated with a politicized curriculum that uses textbooks full of shameful content from racism to cannibalism, including negative commentary about the police and firefighters.

You stood by while our higher education universities were infiltrated by the CCP.

You stood by as the People of this state were and are misled by our illegal health administration as it withholds vital information about the experimental mRNA gene therapy.

You stood by insisting that the gene therapy shots are harmless when VAERS own reporting website lists over 17,000 deaths due to adverse events related to the "vaccine." It is verified through studies that only about 1-10% of actual injuries or deaths are reported.

You stood by while buses of illegal immigrants were, and still are, offloaded into our small towns in the dark of night.

You allowed schools to mask our children for money, knowing full well that according to Arkansas state law, restricting the breathing of a child is child abuse.

Methods proven to heal were disallowed and meds that kill were administered, ripping away our right to choose our own medical care and treatment. Effective treatments like ivermectin and hydroxychloroquine, vitamins C, and D as well as zinc were kept from the people and discussion of their use censored by media and elected officials. You helped deny the People life-saving measures, and instead pushing potentially dangerous drugs.

This is a "work free state," yet you allowed corporations to force experimental vaccinations on unwitting people who were not made aware of the risk involved.

You stood by while countless human lives were destroyed by an experimental gene therapy. It does not matter what other victories you have achieved when you have not stepped up to fight the biggest and most important issues in American history. Up to now, you have failed this state. You have failed this country. You have failed the people. We no longer consent to your failed governance.
