

**TO:** Attorney General Todd Rokita, Secretary of State Holli Sullivan, Governor Eric Holcomb, The Legislature of the State of Indiana, Indiana Mayors, Indiana City Councils, Indiana County Councils, Indiana School boards, and Indiana Sheriffs.

**FROM:** We the People of the State of INDIANA

We the American People, citizens of the State of Indiana, remind you that, under our Constitutions, governments derive their just powers only from the CONSENT of the governed. Because of your failures of leadership and failures to protect the fundamental rights of your constituents, our governments are becoming destructive of the rights, privileges, and well-being of the People. We the people of this state have called, emailed, protested, and remonstrated to school boards, council meetings, and committee hearings. With one voice, we demanded that you preserve and protect our freedoms. We offered you ample opportunities to address these issues, yet you all **stood by** while the tyrannical Governor, overreaching mayors, and an unaccountable federal leviathan destroyed our State and injured the lives and livelihoods of our people.

We **demand** that you answer for your inaction, and we will continue to utilize all forms of communication to call attention to your failures and promote your impending removal from office. We have determined that if you are not standing up for all our freedoms, you are part of the problem. The Governor, Secretary of State, and legislators will now stand by and watch as we peacefully remove them from their respective positions.

Attorney General Rokita, you have a choice to stand with us and fight to secure our constitutional freedoms or you can just stand by while we also remove you. We the People of this Great State of Indiana **demand** Attorney General Rokita agree to a meeting with us immediately.

How have you failed us?

1. **You stood by** while tyrants attacked our most basic rights to live and work freely, using fear and tyranny to lock us in our homes and attack our rights to bodily autonomy.
2. **You stood by** while jobs, schools, weddings, funerals, reunions, festivals, concerts and football games were shut down, yet [thousands freely marched in our streets \[1\]](#).
3. **You stood by** while our kids were deprived of their education, were [muzzled by political pseudo-science \[2\]](#).
4. **You stood by** while school boards, [bribed by federal money \[3\]](#), acted against the people to remove our 1st amendment rights and act in a manner unaccountable to the people. They then took it further by contacting the Biden DOJ to [label Indiana parents as American terrorists \[4\]](#). Why, because we are defending our children's right to an education free of indoctrination and to breathe freely. *We have seen no action from you in our defense.*
5. **You stood by** while small businesses were shattered, [meanwhile Amazon made record profits \[5\]](#).
6. **You stood by** while experimental drugs and the [most dangerous and deadly vaccines of \(at least\) the last 30 years \[6\]](#) were forced upon us at the gun of economic ruin.
7. **You stood by** while our elderly loved ones were [locked away from us \[7\]](#) and died because they were neglected and you, Governor Holcomb, signed the bill to cover this malfeasance.
8. **You stood by** as occupancy, mask, and [vaccine mandates \[8\]](#) were imposed by private corporations under color-of-law on customers and employees and students. 11. **You stood by** while our Secretary of State allowed us to vote on outdated election machines that [have not been certified since 2017](#).
12. **You stood by** while the Arizona audit [uncovered \[13a.\] just how vulnerable \[13b.\] our election systems are \[13c.\]](#) and yet the people have not seen any of you take ANY action to restore our faith in election integrity.
13. **You stood by** as Dr. Anthony Fauci and the NIH lied about the origins of the virus. This led to precious lost response time and political pressure on China that cost the lives of Indiana citizens.
