### TERMS AND CONDITIONS: PLEASE READ ALL ITEMS

•All clients ("you") must sign a boarding and grooming contract with B&S Boarding and Grooming Kennels ("the Kennel") for each pet boarded. A copy of this contract will be furnished to you upon your request or can be printed from our Web site.

•You realize that you are responsible for payment of all boarding and grooming fees and any additional costs incurred by the Kennel, including any/all veterinary costs, at the time the pet is released.

•If you are having your pet groomed, you understand that the Kennel agrees to exercise reasonable care and all necessary precautions during the grooming process. You are aware that if your pet is being groomed there are inherent risks involved, such as clipper burn, brush burn, or nicks and cuts. For pets that are matted, it may be necessary to shave or dematt the pet. Severely matted pets will have to be shaved (clipped down) for their health. A matted pet will not be bathed prior to matt removal, as the matting will hold moisture and can cause serious skin problems, if such problems do not already exist. All grooming procedures may have consequences such as discomfort, clipper burn, brush burn, or nicks and cuts. You agree to hold the Kennel, the owners of the Kennel, and all of the Kennel's employees free of all responsibility and/or liability for all such consequences.

•If you do not pick up the pet within ten days of the day we agree upon, the Kennel may assume that the pet is abandoned and you authorize the Kennel to dispose of the pet as the Kennel sees fit. You understand that the Kennel will prosecute to the fullest extent of the law. If the Kennel keeps your pet on its property longer than originally agreed upon, our agreed charges will continue to accrue against you in addition to a \$5.00 per day feed charge. When you pick up your animal, you will be obliged to pay the full amount of the bill and each day's accumulated charges. You also agree to pay a finance charge of 4% per month that the bill is unpaid along with any and all collection costs, court costs, or attorney's fees incurred by the Kennel relating to non-payment and/or abandonment.

•We will exercise reasonable care in boarding and/or grooming your pet. You agree to hold the Kennel, the owners of the Kennel, and all the Kennel's employees free of all responsibility and/or liability for illness, disease, theft, fire, running away, injury, or death of your pet in the absence of gross negligence.

•You agree to be solely responsible for any and all acts or behavior of your pet while it is in the care of and on the property of the Kennel. You also agree to be solely responsible for any property damage and/or bodily harm or injury your pet may cause while in the care of the Kennel.

•You represent that your pet has not been exposed to rabies, parvo, distemper, or bordatella within a thirty-day period prior to boarding.

•If your pet becomes ill or is injured while being boarded and/or groomed, the Kennel will take any immediate emergency action necessary for your pet's well-being. If it is necessary to seek veterinary care for your pet, you agree to have the Kennel transport your pet to the veterinarian of the Kennel's choice with a minimum \$10.00 fuel charge. You also authorize the veterinarian to perform any treatment/procedure/service the veterinarian deems medically necessary for the health and well-being of your pet. You understand that you will be responsible for all veterinarian costs, and that, should veterinary care be undertaken, no guarantee of successful treatment is made.

- You certify that you are the sole owner, or authorized agent of the sole owner, of this pet and that there is not now any lien or mortgage against the pet.
- You agree and understand that check out time is 12 noon of the day agreed upon; after 12 noon, you will be charged for another day's fees and costs.
- You agree and understand that, for everyone's safety, all dogs and cats must be brought in on a leash or in a carrier and must remain that way until they are put in their pens. Crates cannot be put in the pens with the pets.
- You agree that the Kennel is not responsible for lost or stolen items.
- You agree and understand that no blankets or bedding can be brought in with your pet. If you would like your pet to have a blanket, please ask: the Kennel would be happy to put one of its blankets back with your pet. However, if your pet tears up the Kennel's blanket, there will be a replacement charge. If such a charge should be incurred, the Kennel agrees to provide proof of the cost of the destroyed blanket upon your request.
- You agree and understand that pets boarded together must eat the same food without separation, must get along, and must live in the same household. If they have to be separated, you will be charged for each additional pen that is occupied for each day your pets are separated. You agree that the decision to separate pets is left to the discretion of the Kennel, and the Kennel agrees to not separate pets absent cause.
- You agree and understand that all holiday bookings are to be **Pre-Paid** and are **Non-Refundable/Non-Transferable** by the dates specified. If not paid by the specified date, the reservation will not be held. **(Please understand that there are No Exceptions to this policy for any reason. If you are not sure of your plans, please do not book the space until you are certain.)**
- You agree and understand that all business is done during our posted business hours. If the Kennel is forced to do business outside of its posted business hours, you will incur a \$30.00 after hours overtime charge.
- You agree and understand that instructions are taken down at the time of check-in (for both boarding and grooming requests) from the individual who brings in the pet. If it will not be you bringing your pet in, please make sure that the person that does understands what services you would like, such as bathing/grooming, exercise, and feeding and medication instructions. The Kennel will go by what this person says unless otherwise taken care of beforehand. If the person bringing in the pet requests a bath that you did not want, you will be charged for that service. So please make sure that everyone is on the same page. For grooming, make sure that the person bringing in the pet understands how you would like your pet groomed because we will groom by the instructions given at check-in. If that person says shave down your pet, then that is what will be done.
- You agree that if the Kennel finds fleas or ticks on your pet, the Kennel must give your pet a flea bath so that no other pets within the building get fleas or ticks. That bath costs \$6.00, in addition to the standard bath price for your pet. Your understanding on this issue is appreciated. You agree and understand that, if your pet is found to have fleas or ticks, the Kennel cannot be held responsible or guarantee its treatment to be 100% effective after the pet has left the Kennel's building.
- You agree and understand that this contract is good for any/all future business with the Kennel, unless amended by the Kennel, for which a new contract will be presented.
- You agree that, aside from dates of performance, boarding and grooming fees, and specific instructions given by you at the time of the delivery of your pet, this contract represents our entire agreement. Any disputes arising from our relationship shall be decided under the law of the State of Indiana and in the venue of Hendricks County.

By signing this contract and leaving your pet with the Kennel, you certify to the accuracy of all information provided about you and your pet, and agree to all of the terms and conditions listed herein.
