2. **PAYMENT SCHEDULE**

A non-refundable deposit of 40% of the estimated total value is required before the Artist begins the commission and is due at the time of signing the contract. The balance of payment is due upon satisfactory completion and delivery of the artwork as described above. If at any time the Purchaser no longer wishes to proceed with the commission, the deposit is non-negotiable for refund. Payments through PayPal, CashApp, Zelle, credit cards, online via website, or cash are accepted.

3. **DELIVERY**

The Artist agrees to complete and deliver the commissioned artwork on or before the following date, _____. In the event that the Artist is unable to deliver the commission, shipping will be included in the total cost of payment. For out-of-state commissions, shipping must be included in cost, and shipping speed will be dependent upon the Purchaser.

4. **COPYRIGHT**

The Artist retains the copyright to all works commissioned by the Purchaser, including all reproduction rights and the right to claim statutory copyright. No artwork may be reproduced or altered without the written consent of the Artist. Photo photography of jewelry, clothing items, oddity items, and cosplays are welcome only if agreed upon by the Artist prior to the photos being taken. Credit to the Artist is necessary when posting on social media, or any public platform. Photos of any artwork created by Artist is subject to online promotion, publication, or use as a basis for similar items to sell.

5. **RIGHT OF REFUSAL**

If the Purchaser does not wish to purchase the commissioned artwork, the Purchaser may refuse at any time during the commission's progress. In this case, the artist will retain the artwork and the non-refundable deposit. This is free of any claims or interests of the Purchaser, and the Purchaser will not be subject to any additional fees, nor have a balance due to the Artist.

6. **RETURNS**

There are no returns once the Purchaser takes possession of the artwork, Photos of the commission will be delivered upon request or at the Artist's disposal prior to delivery of the commission. For clothing items, specifically custom- clothing, fittings are optional yet encouraged. Up to two fittings are available upon request, without additional cost.

**Depending on the distance from the Artist and the Purchaser, the Artist may request the Purchaser to come to their establishment for fittings, alternate between the Purchaser's establishment and the Artist's, or a travel fee may be agreed*

upon prior to signing the commission contract.

7. ADDITIONAL FEES

The Artist may at any time require additional fees for labor, leather-working, changes to original design, unexpected length of time for completion, rush fees, or dependent upon the amount of time invested into the commission contract, a non-negotiable fee of \$50 may be included in the commission cost as a Commission Consultation Fee. The Artist is required to inform the Purchaser if this fee will be included in the commission contract and will not continue with commission contract until payment in full for the Commission Consultation Fee is received. This fee is *not* included in the cost of the deposit, or total price, and will be added to the contract as a separate charge.
