TRAILER RENTAL AGREEMENT

1. Rental Property: Owner agrees to rent the following trailer (the “Trailer”) to Renter:

2. Rental Period: The rental period shall commence on _____ [start date] and terminate on _____ [end date], unless otherwise agreed upon in writing by both parties.
3. Rental Fee: Renter shall pay Owner a rental fee of \$_____ [rental amount] for the entire rental period. Payment shall be made as follows:
 - A deposit of \$_____ [deposit amount] is due upon signing this agreement.
 - The remaining balance of \$_____ [remaining amount] shall be due on or before the commencement of the rental period.

4. Security Deposit: In addition to the rental fee, Renter shall provide a security deposit of \$_____ [security deposit amount]. This deposit shall be returned to Renter within seven days after the termination of this agreement, less any deductions for damages or unpaid fees.
5. Use of the Trailer: Renter shall use the Trailer for lawful purposes only and in accordance with all applicable laws and regulations. The Trailer shall not be subleased, assigned, or used by anyone other than Renter without prior written consent from Owner.

6. Maintenance and Repairs: Renter agrees to maintain the Trailer in good condition during the rental period. Renter shall be responsible for any damage to the trailer, except for normal wear and tear. Renter shall promptly report any accidents or damages to Owner. The owner shall be responsible for repairing any damage not caused by Renter's negligence.
7. Insurance: Renter shall maintain insurance coverage for the Trailer during the entire rental period, with coverage limits and types of insurance as required by law. The owner may request proof of insurance from the Renter.
8. Return of the Trailer: Renter shall return the Trailer to Owner in the same condition as it was at the commencement of the rental period, clean inside and out, on or before the End Date of this Agreement. Failure to return the Trailer as specified may result in additional rental charges.
9. Termination: Either Party may terminate this Agreement with written notice to the Party if the other Party breaches any material term or condition of this Agreement.
10. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the state of Illinois.
11. Entire Agreement: This Agreement constitutes the entire agreement between the parties and supersedes all prior oral or written agreements, understandings, or representations.
