Meeting was called to order with the Pledge of Allegiance

Dale asked for a motion to pay the current bills. Cory made the motion, seconded by Dan. Motion passed unanimously.

Old Business: 100 Ton initial fill of Salt was ordered. Sewer meters were calibrated 10/23/25.

New Business: The General Funds, State Funds and Sewer Funds budgets for 2026 were presented; Cory made a motion to have budgets advertised and on display for at least 20 days before the December 1, 2025 meeting for final budget adoption. Dan seconded; motion carried.

Quote of \$10,141.30 from Plyler Entry Systems to have three of the man doors replaced, 2 on the office building and one on the rental hall. Cory made a motion to have these replace, Dan seconded. Motion carried.



Chatfield Drilling was called because the water has had very low pressure. The water tank is leaking and the pump needs replaced. Quoted price is \$5,405.98. Chatfield Drilling is scheduled to do this work on November 6, 2025.
