## COOLSPRING TOWNSHIP, MERCER COUNTY, PENNSYLVANIA ORDINANCE NO. 94 AN ORDINANCE DESIGNATING CERTAIN TOWNSHIP ROADS UPON WHICH ALL TERRAIN VEHICLES MAY TRAVEL

BE IT ENACTED by the Board of Supervisors of Coolspring Township, Mercer County, Pennsylvania, in lawful session assembled, and IT IS HEREBY ENACTED by authority of the same that:

## SECTION 1. <u>Definitions</u>

## A. All-Terrain Vehicles:

- Class I All-Terrain Vehicle (ATV) A motorized off-highway vehicle 50 inches or less in width, having a dry weight of 800 pounds or less and traveling on three or more low pressure tires (10 pounds per square inch or less) with a seat designated to be straddled by the operator.
- Class II All-Terrain Vehicles (ATV) A motorized off-highway vehicle 50 inches or less in width having a dry weight which exceeds 800 pounds, traveling on four or more low pressure tires (10 pounds per square inch or less) and having a bench seat.
- B. <u>Department:</u> The Department of Conservation and Natural Resources of the Commonwealth of Pennsylvania.
- C. <u>Headlamp:</u> A major lighting device to provide general illumination ahead of the vehicle.
- D. <u>Highway:</u> The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular traffic.
- E. Tail Lamp: A device used to designate the rear of a vehicle by a warning light.

SECTION 2. The following roads within the Township of Coolspring, Mercer County, Pennsylvania are designated as special All-Terrain Vehicles roads. All roads listed below will share the road with vehicular traffic.

Airport Road Andrusky Road Babcock Road

Coolspring Church Road East & West Cornell Road

Esposito Road Holmes Road Johnston Road Junction Road Ligo Road

Magner Road McEwen Road Miller School Road North Mills Road Oakland Road Old Fredonia Road

Orr Road

Plummer-McCullough Road

Quarry Road Rogers Hill Road Russell Road Tait Road

Turner Station Road

SECTION 3. All All-Terrain Vehicles must be registered with the Department and insured. The operator of any All-Terrain Vehicles must be 16 years or older and carry a registration certificate. The vehicle must display a registration plate and expiration sticker, as required by Pennsylvania law. The registration plate must be affixed to the back of the ATV.

SECTION 4. Designation of certain roads as ATV roads of the Township of Coolspring does not impose liability on the Township of Coolspring for any property damage or personal injury that may result from the use of ATVs on said roads.

SECTION 5. This ordinance shall become effective as of the date of enactment.
