Meeting was called to order with the Pledge of Allegiance

Dale asked for Public Comment stating that you must be signed in, state your name and come to the front.
Eric Lawrence requested speed limit signs on Tait Road. He had contacted the State Police but there needs to be signs posted in order to enforce speed limit.

Dale asked for a motion to accept the minutes from the August 4, 2025 Regular Monthly Meeting as presented. Cory made the motion, seconded by Dan. Passed unanimously.

Old Business: Driveway approach at Extension Office. Waiting on Mercer Borough and Commissioners.

New Business: Terri presented the 2026 Minimum Municipal Obligation (MMO) Worksheet for the PMRS Pension Plan. It is \$3,443 for 2026. Cory made a motion to accept the MMO as presented. Dan seconded the motion. Motion passed unanimously. MCRPC is asking for a letter of support for a Mercer County ATV Trail Study grant application. Supervisors agreed to support. General Assembly of PA increased the amount of pay for Supervisors under Act 94 of 2024 from maximum of \$1,875 to \$3,145. This will have to be done as an ordinance. Discussion on keeping the payment on a per meeting basis and increasing to \$200 per meeting. This increase can only apply to new Supervisor terms. Terri will advertise the ordinance as required and have it ready to pass at the October meeting.

COSTARS Salt Contract for 2025-2026 season is \$69.43 per Ton.

There was a car fire that damaged W. Cornell Road. This road was just seal coated. Cory has called for quotes to get patched. The brakes and gas pedals are sticking on the John Deer High Lift. Dale is going to call 5-Star to get fixed.

Having nothing further to discuss, Dale asked for a motion to adjourn. Cory made the motion. Meeting adjourned.

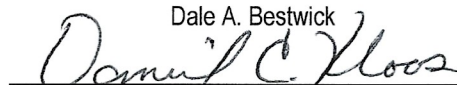
