

## **Singing Tree General Release of Liability Waiver Form for Caregivers, Nanny's, and Extended Family Members**

This form must be completed for all caregivers, nanny's, babysitters, or extended family members (ex. Grandparents) who may enter Singing Tree's space and surrounding property for drop offs, pick ups, visits, etc. throughout the year. All persons choosing to enter the Singing Tree space and surrounding property, do so at their own risk, and agree not to hold Singing Tree Preschool nor Mirandy Cook responsible for any injuries suffered by the undersigned while at the Singing Tree space or surrounding property. While visiting Singing Tree, adults/caregivers must take full responsibility for the children in their care including younger/older sibling's safety.

In consideration for being allowed to visit Singing Tree Preschool space and surrounding property, the undersigned agrees to the following terms:

- 1. Assumption of Risks.** The undersigned acknowledges that participation in entering the Singing Tree Preschool space and surrounding property involves inherent risks. I understand that Singing Tree Preschool and Mirandy Cook has attempted to create an injury free space, however, I acknowledge that there are inherent risks at any space (including Singing Tree Preschool), and that I/We could potentially get hurt while visiting the Singing Tree space or surrounding property. Inherent risks may include, but are not limited to, slipping and falling (ex. on ice in Winter months, mud or wet surfaces on rainy days); a tree branch falling in a wind storm; tripping or losing one's balance on uneven ground, a rug, or a toy; use/misuse of playground equipment, furniture, toys, or other materials; injury caused by another visiting person or child; allowing younger/older children and siblings to utilize space/materials inappropriately for their age/strength/abilities; etc. The undersigned assumes ALL inherent risks associated while at Singing Tree Preschool space and/or surrounding property.
- 2. Release and Waiver.** The undersigned, on their own behalf and their successors, heirs, and assigns, hereby releases, waives, discharges, and

covenants not to sue Mirandy Cook nor Singing Tree Preschool, employees, or volunteers, from all liability to the undersigned, their personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore, on account to injury to the person or property or resulting in permanent disability or death of the undersigned, wether caused by the negligence of Releasees or otherwise, to the fullest extent allowed under Washington State law. I agree to hold harmless, waive, release, indemnify, defend, and discharge Singing Tre Preschool and Mirandy Cook from all liability and claims arising from my family.

**3. Indemnification.** The undersigned agrees to indemnify Releasees from any loss, liability, damage, or cost Releasees may incur due to the undersigned's participation while at Singing Tree Preschool space or surrounding property, whether caused by the negligence of the Releasees or otherwise.

By signing below, the undersigned acknowledges that they have read and fully understands this Release of Liability Waiver, and chooses to enter Singing Tree Preschool space and surrounding property at their own risk. The undersigned adults also takes full responsibility for the safety of their own children/siblings/children in care of, while visiting Singing Tree.
