Last night, a friend Darius Kodjo acted aggressively towards me at the end of the night at a night club, making me concerned, and then displayed drugs and then insisted that I let him back in to my car to return him home. I am filing for this Peace Order to instruct him to cease all contact with me after he has refused to do so.

The back story is that I met Darius Kodjo at iRock Lounge when he was there when I was there singing. We played pool a few times and became friends. One night he drank to much and I got him home safely. (I do not drink even when I'm at the lounge; I sing and have a soda.)

I met his father and got to know his family, and offered to help him not drink so much and try to steer him away from staying out all night, drinking all night, and not showing up for his job. This worked for a brief period of time and I think his father was pleased. I have his father's phone number and would always keep him up to date on our whereabouts when I picked him up, so as to avoid Darius going out with other friends who his father did not know and who would not keep him out of trouble. **I agree to do the driving since it is my car, and Darius was to pay for the outings.**

A few day ago, Darius asked if I wanted to go to a comedy show in Timonium, Maryland. I agreed. I picked him up and we went to the show. He only had two beers. I had a soda. The show was good. There was a marked difference in his demeanor however at this show, because he was all of a sudden acting like I was his employee instead of his friend. He sat through the entire show not saying much to me while facing the stage, and offered me \$100 to go up and let myself get insulted by the comedian. It was as if we was using the fact that I did not have a lot of money as some kind of control tactic. At some point, he mentioned wanting to stop by a few others places after the comedy show.

This ended up being where more problems arose. I want to point out that I am 52 years old and have no interest in going somewhere after 11pm or 12pm at night after I've already been to comedy show. And my friend knows this. So, for him to want to continue to from one place to another is ridiculous, and his father doesn't like it, either. (He even texted me that we should go

to Casino Live after the Backyard.)

Having said this, we went to the Backyard. As usual, I had soda ... I do not drink. As the night progressed, the bar moved the chairs and opened up the dance floor. People were dancing, the night went on.

In any event, after the dance hour ended at Backyard at 1:30am in the morning, I wanted to get something to eat. I'm a diabetic. I have to eat again at this hour. So, we go to a food place and he says order some food. When I do, I ask him for \$48 to pay for it since he's been using cash. He says something insulting in front of the people sitting next to him waiting on their food, and then pulls out some drugs from his pocket and tries to hand them to me in front of the others. I was expecting cash, so I pulled my hand back and stepped back. He said something else out loud about drugs in front of everyone.

I walked out without the food, got in my car, and drove away, leaving him in the food place, talking to the other people.

Darius kept called me. I sent him the following text: "Dont display your f**king drugs in front of me and talk about the sh*t in front of other people while refusing to pay for food after telling me to order food, a**hole. I told u I'm diabetic. And I dont do drugs or sell drugs, u do. And I dont allow that sh*t in my car. I'm filing with the precinct tomorrow. U will never pull your bullsh*t game playing on me again."

What is telling in this situation is that I recently filed for a Peace Order against another person named Joyce after she pulled out drugs and blew them in my face while we were driving in my car. And, Darius not only knows who this person is but knows I was upset about what happened. So, for him to try to do the same type of thing is a sign that he is intentionally attempting to associate me with his drug use or drug deals.

I called the police in Timonium and insisted that they make a report about the incident as I

I have also submitted a Peace Order for Joyce Naree and believe that the acts committed by her a part of an overall continued strategy at gang stalking and elite capture in an effort to coerce me in to doing something or joining some group, for what ever reason.

The patter represented by Darius Kodjo is similar to the pattern displayed by Joyne Naree. This is why I consider these two incidents to be connected.
