Main Statement of Concern

On May 24th, 2023, Joyce Karee was driven up to the iRock lounge, and I believe it was another attempt to convince people that I was a dangerous person. She also brought people with her. Convincing others that I am a danger to her or others places me at risk of harm from others who may believe what she is saying. That is why I consider this situation a threat to my safety.

This is my second attempt to obtain this Peace Order against Joyce Karee. The first time I filed a Peace Order against Joyce Karee, it was accepted by the commissioner. But the police did not arrive at her house soon enough to serve her before she left, and I was not present at court to discuss it with the judge.

I am filing this Peace Order to compel Joyce Karee to stop going to the lounge, turn over the illegally recorded file that made, apologize in writing, tell the court who she shared the file with or who she may be speaking to about me, and receive financial compensation from her and or her associates for the damage done to my safety and to my reputation.

Back Story

Joyce Karee came in to the Karaoke Lounge in called "iRock" at 15964 Shady Grove Rd, Gaithersburg, MD 20877 and started talking with me and said she wanted to learn how do the work I do. We exchanged phone numbers. Over the next few days I discussed with her some of the requirements. She does not have car, so, I would pick her up. As we got to know each other, I noticed she kept asking me for rides.

In addition, there were other concerns. She kept calling two guys and telling them where she was. She also kept trying to get me to let these guys in to my house. On one occasion one of these guys showed up at the iRock lounge. She also started telling me stories of drug dealing, but, I told her I wanted nothing to do with it.

Then she asked for work. I told her that she could clean my house. I withdrew \$120 out of my bank account and gave it to her. Surprisingly, she texted somebody, then, within a few minutes, a white car pulled up beside us and she gave them the money? And then she started lighting up a liquid in a foil and literally smoking with a pipe and doing drugs right in front of me in the passenger seat of my car. She kept blowing it in my face asking me if I wanted to try. I ordered her out of my car.

She got out at 7-Eleven near my house and said she was calling her friends to help her "deal" with me. Her friend from Baltimore is the one that has been driving her around, and I suspect it was him she was going to call; he has driven her before.

In the car, she also said that she recorded me, as if I was supposed to somehow be afraid because of that, and as a result admitted to breaking the law in Maryland by recording someone with their permission.

I told her to get out of my car. Later that night I went directly to Rockville, MD. **She apparently called driver to come get her and the both of them went to my house and entered**

illegally to take some food and some other things, and left. (I filled a police report about the breaking and entering using my access code without my permission.)

Then, that same night, she called me again trying to convince me to come back to my house, while she and her driver were there, and I suspect they were both there waiting to cause some kind of harm. **Because of all that was going on, I stayed out in my car all night in Rockville, MD. I also filed for a Peace Order.**

Meanwhile, apparently, Joyce's driver drove her to the iRock lounge where she told every one that I was dangerous, but, they all disagreed that was a danger, and she left, frustrated. (Joyce told me herself on the phone that she had went there and that she was upset with them and she was "never going back.") She called me several times after this incident attempting to get her bottle of alcohol back from me. I still have the bottle in my possession.
