Main Statement of Concern

This is a request for a Peace Order against Lance Smith for continuing to contact me after I ordered him to stop. On November 1st, 2023, Lance Smith got in to my Facebook account and added himself as a friend on my Facebook page. I discovered it and removed him, and responded by filing this Peace Order.

On June 8th, 2023, Lance Smith tried to contact me after I had told him over a year ago to stop contacting me. He has placed me in fear once again that he would start up with his sexual advances towards me. (See appendices for details.)

The respondent is notorious for his strange sexual behavior towards others, as evidenced not only in my experiences with him but also in the experiences others have had with him, including good friends of mine from the Jewish Community: the Laz Twins (see appendices for details and dates). The respondent has repeatedly been aggressive in dealing with the Jewish Community as well as in dealing with me, hence this Peace Order.

The respondent has repeatedly attempted to contact me after I requested that he cease contact, because of his unwanted sexual advances towards me.

On or around November 28th, 2022, while on the phone discussing business with me, at the end of the conversation, he whispered to me: "Do you watch porn? Do you jack off?" He kept up this line of questioning until I yelled at him and hung up the phone.

I believe it was the next day on November 29th, 2022, where I sent him text messages accusing him of sexually harassing me, to which he admitted (see appendices for details and dates).

Main Statement of Concern (Continued)

I have refused to get on the phone with him for over a year (since last year's Thanksgiving) and haven't even returned to his house to retrieve my digital camera's battery charger that I left there. Yet ... still ... he will not stop trying to insert himself in to my life.

Inappropriate Sexual Advances

I have sent him emails to leave me alone, sent him text messages to leave me alone, and unfriended him on Facebook. Yet, none of this has worked.

Lance Smith is a former employer. I used to work for him when I did local entertainment gigs. I have been disgusted by his behavior many times when he made inappropriate comments towards the female dancers that worked for him, or, when he harassed them in an inappropriate manner.

In the most notable instance, I participated in a impromptu "mediation" meeting between Lance Smith and the mother of two Jewish young girls who he was abusing. Lance had signed the girls up to a contract, and they believed in him. But he acted aggressively towards them by constantly calling them at their day job, and that started to concern their mother.

She called an emergency meeting after complaining to him in an email. Lance sent me the email and asked me to come with him to the meeting. When we met, the mother of the girls threatened to sue if he did not let the girls out of the contract. After pressure from me, he agreed to cancel their contract.

Illegal Business Practices

As a show of good faith, the twin's mother sent Lance free legal advice on his illegal contract, free-of-charge. Lance did not understand the changes, so, I created several updated contracts, each for the different roles of the entertainers that he hired.

I offered to sell him the redone contracts for just \$50.00. He said "let me check them out" and that he would think about it. He never paid. Several months later, when he forgot that I had written them, he sent me my own contract back via email claiming it was his. I was furious that he was using them.

Conclusion

I am seeking a Peace Order against Lance Smith to compel him cease contact with me and get whatever help he needs in dealing with his issues.

Lance, I'm talking about the other conversation you brought up Lance.

You mean the discussion about sexuality and Christianity? You are trying to charge me for that conversation? You have tell people ahead of time if you are trying to charge them for conversations.

No, Lance, what you did on the phone last night was a lot more than a private conversation. And since I record all my phone calls bcs my lines are business lines, and make that clear to all that I do, then ... I can easily see that it was not what you say it was.

You cannot dive in to private conversations and put pressure on people to tell them secrets or facts about their own behavior, and then try to mask it as a conversation.

What you did is not uncommon in the law enforcement arena. And there is a name for it.
