Today on Tuesday, May 30th, 2023 at 5:00pm I received a phone call from a woman accusing me of damaging her Corvette that was parked at Criswell Chevrolet. This company has illegally given out my personal contact information in an incident that involved their business,, when I am one of their customers, violating my confidentiality rights and instituting an act of a hate crime against me, which is the reason for this filing of a Peace Order.

Several days ago I had my 2007 Nissan Sentra serviced at Criswell Chevrolet. I paid around \$98 dollars for service, and came and picked up my car in another car. In the afternoon of Wednesday, May 24th, 2023, I returned to Criswell Chevrolet to pick up the other car I left there when I picked up my Nissan Sentra. I arrived and asked for a ride home and back to return in order to remove get both cars from their lot.

I was told that there were no rides available and to take my other vehicle home and return the next day to with a ride from Criswell, so that I could pick up the other car. I complied and left the service center area and proceeded to the parking area. **As I went to the parking area and attempted leave, I was confronted by Ron Karolick. He got in front of my way and started asking me questions. He accused me of parking there illegally and said I had not gotten my car serviced there. I disagreed. He got closer, raising his voice, getting upset, and ordering me to get the car off of his lot. Again, I told him I was a customer; I began to fear he would punch me. I asked him to go in to the service area and ask this service personnel is I was a customer.**

Once we confirmed I was a customer, he ordered me out. I told him that I was told to come back tomorrow. He then order his representative, Mike Holda, to give me a ride immediately back from home ,today, so I could remove both vehicles, today.

So, I left and drove one car home. I called, got a pickup from my house from Criswell, and returned there to drive the 2nd vehicle back home. Upon returning, I was told that I had damaged a Corvette ... but ... also told "We can probably just buff it out, we don't need to charge you for the damage" they said. It was clearly a threat. **As I left, Mike Holda also started acting aggressively towards me, and yelled out in front of other customers: "Thanks for damaging our corvette!" and started laughing.** I left.

Then, today, I received a phone call from one of their customers who threatened to have her lawyer call me.

As a customer of their business, I am not liable for incidents that occur on during their course of business nor to I admit or agree that I damaged any Corvette nor did I say to them or agree that any of my vehicles damaged any of their vehicles.

I do not appreciate my personal confidential contact information being given to another customer without my permission which is a violation of the credit card confidentiality compliance rules and regulations that any business must follow when processing credit payments and holding private contact information. Furthermore, it is gross misconduct and an act of aggression to threaten me with a financial damage after threatening me with a physical assault, which is what Ron did when I was in the parking lot.

All of this is because Ron and Mike are not happy with the fact that I did not get their services and did not pay over \$1,000 for work, and then after being harassed and made to feel not safe, I was threatened with a lawsuit, and then one of their customers called me. (I still do not know their customer's name but telling the customer that I damaged their car constitutes defamation of character and libel or slander.)

For these reasons, I am filing for a Peace Orders for both Ron Karolick and Mike Holda (separately) to protect me from stalking, defamation of character, assault, threats of fraudulent financial abuse, and any other future attempted acts of aggression.

**The Unique Relationship Between Native Americans and The United States
Insists on Taking These Issues Seriously**

This Peace Order is only one example of what I believe to be a sustained effort at constant harassment, stalking and abuse by individuals and groups that I am unable to completely identify or understand.

What I do understand it that Native Americans such as myself have been here in the North America for over 20,000 years and I have no intention on going anywhere else. Furthermore, I relocated from California to Maryland in 2001 and also do not want to forced to leave my new home just because the State of Maryland continues to be unable to provide for my safety.

Based on previous experience with law enforcement I am CRYSTAL CLEAR that it is not the intent of law enforcement to not assist, properly in this case. But I believe, unfortunately, that it is in fact happening, currently.

Again: I do not believe this is intentional ... the respect that law enforcement had for me in California, the respect law enforcement had for me during a national security incident, and the respect that law enforcement had for my 2 year old puppy during a recent hospital stay ... are all proof of their clear intent to provide safety and go above and beyond to protect.

However in the prompting this Peace Order, as with other incidents that have harmed me, I

do not believe enough is being done to take a step back and connect the dots. The result is that a pattern continues and has no sign of stopping, which has resulted in the complete destruction of my ability to work and earn a living in Maryland.

I would like to remind the State of Maryland that the First Vice President of Color was a Native American chosen by Republican President Herbert Hoover. His name was Charles Curtis, a member of the Kaw Nation, and he served from 1929 to 1933. Furthermore, there are these efforts at assisting Native Americans in America:

1. Proclamation, September 28, 1915, Issued by President Sherman Coolidge - Declared the second Saturday of each May as American Indian Day and significantly declared American Indians as citizens; and
2. Executive Order 13007, May 24, 1996, Issued by President William J. Clinton – Indian Sacred Sites; and
3. Executive Order 13175, November 6, 2000, Issued by President William J. Clinton — Consultation and Coordination With Indian Tribal Governments; and
4. Executive Order 13336, April 30, 2004, Issued by President George W. Bush – American Indian and Alaska Native Education; and
5. Executive Order 13592, December 2, 2011, Issued by President Barack Obama – Improving American Indian and Alaska Native Educational Opportunities and Strengthening Tribal Colleges and Universities; and
