Main Statement of Concern

Second Refusal to Cease Contact

On December 24th, 2023 at _____ EST, Thomas Marton refused to cease contact with the Stephen Widener. On December 24th, 2023 at 6:45pm EST, Stephen Widener sent Thomas Marton an emailing to cease all contact after Thomas Marton came over to the house and took pictures of the inside, including where Stephen sits to do his work. Stephen demanded that Thomas Marton destroy the pictures on his phone because it places him in fear as he doesn't understand why Tom would be gathering evidence about where Stephen sits and sleeps in his house. Tom would not delete the pictures and left.

First Refusal to Cease Contact

On November 15th, 2023 at 12:47am EST, Thomas Marton ignored Stephen Widener's efforts to get him to cease all contact. On November 10th, 2023 at 3:17am EST, Thomas Marton ignored Stephen Widener's efforts to get him to cease all contact. On November 6th, 2023 at 11:18pm EST, Stephen Widener sent Thomas Marton an email demanding that he cease all contact with him, his neighbors, and his mother. This was in response to Thomas Marton threatened to cause harm to Stephen Widener on November 1st, 2023 at 9:31pm EST. (See appendices for more details.)

Potential Reasons

Stephen Widener believes that there are several potential reasons why Thomas Marton will not cease contact.

Reason #1

One reason could be because Thomas Marton is interested in forcing the sale of Stephen Widener's house so that he can take proceeds from the sale to pay himself back money he feels he is owed, without having to go through a civil process to prove to a judge that the debt is owed. Stephen Widener is in possession of what he believes are fake foreclosure documents drawn up on his house that don't match what the mortgage company tells him when he calls them.

Main Statement of Concern

Widener is because Stephen dated a woman that Tom tried to date who rejected him. (See appendix for details.)

Reason #3

Another possible reason why Thomas Marton will not cease contact is because Mr. Marton's actions are a continuation of aggressive retaliatory actions taken against Stephen Widener by Thomas Marton and his associates that led to Stephen Widener being illegally terminated from his federal employment back in 2016.

Stephen Widener found paperwork detailing a transfer of money from the United States to Poland and believes it is something that Tom Marton doesn't want people to know about. This transfer could be the start of a constant financial blackmail scheme that he has been running on the Widener family and continues to run.

In June of 2016, Stephen Widener was a witness to an incident that prompted a traumatic experience for him after he went to his federal agency to warn them of a potential national security risk. The loss of Mr. Widener's federal job was a traumatic experience for him and was a direct result of Thomas Marton's action to stop another employer from intervening to save his job. Mr. Widener believes that Mr. Marton is continuing his harmful actions towards him because he is the son of Mary Widener. Mary Widener interfered in a federal business transaction between Stephen Widener's federal agency housed inside the Old Postal Square Building in Washington DC and Donald Trump and his associates. The problems for Stephen Widener began the same year that Donald Trump was finally able to overcome Mary Widener's interference and purchase the building in the Year 2013. 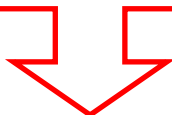

Stephen Widener was told by Lindsay Ford when he tried to return to work there that he had been put on a "No Hire" list so they could not hire him back. He later discovered that the list was in-fact Global and was interfering with his ability to get ANY job ANYWHERE

Stephen believes that this was the reason why Thomas Marton kept trying to force Stephen to apply for white collar 9-to-5 jobs at that time. He believes Thomas Marton knew he could not get these jobs.

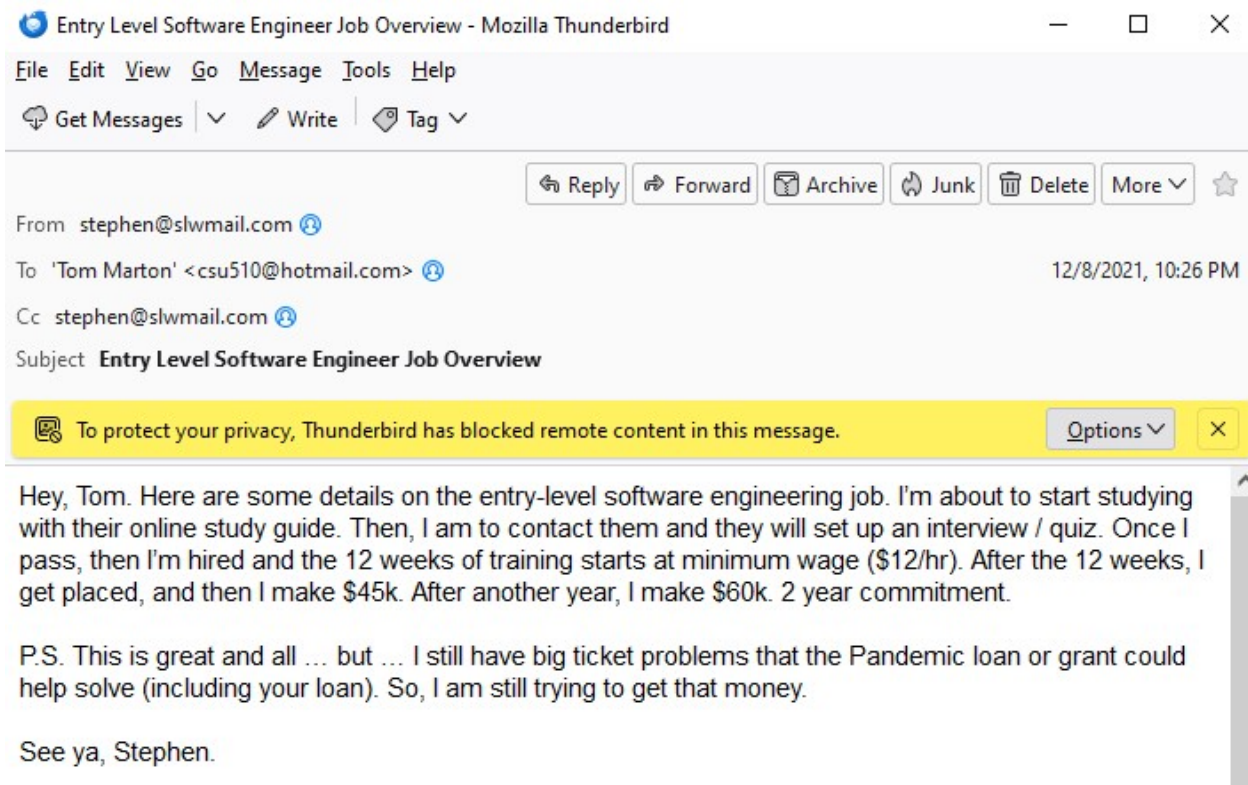

In 1997 there was a lot of turmoil over the issue of historic preservation and Stephen Widener's mother was right in the middle of it along with many of her political colleagues.

repair the newly discovered damage was estimated at \$16,000 dollars, according to the mechanic at King VW.

Later when Mr. Widener was unable to get Mr. Marton to file a police report, he had the White VW towed back Tom Marton's house. Tom ordered him to tow it away and still did not get a police report. Mr. Widener towed the car back to his house but did not have access to his driveway, so, the car was towed by police to the impound yard because it was towed and parked in a residential parking space without registered tags.

Before the car was towed away, Mr. Widener pressed the Montgomery County police department to come out and visit with him to file a police report on the White VW so that he could finally deal with the damage and file with the Maryland Victims of Violent Crimes Fund.

However, the police said that the damage underneath the vehicle was most likely not done at Tom Marton's house and might have been done during the first incident when the car was stolen back in 2019 or 2020. Instead of filing a police report, the police added a sentence to the original stolen vehicle report filed back then when the car was stolen the first time.

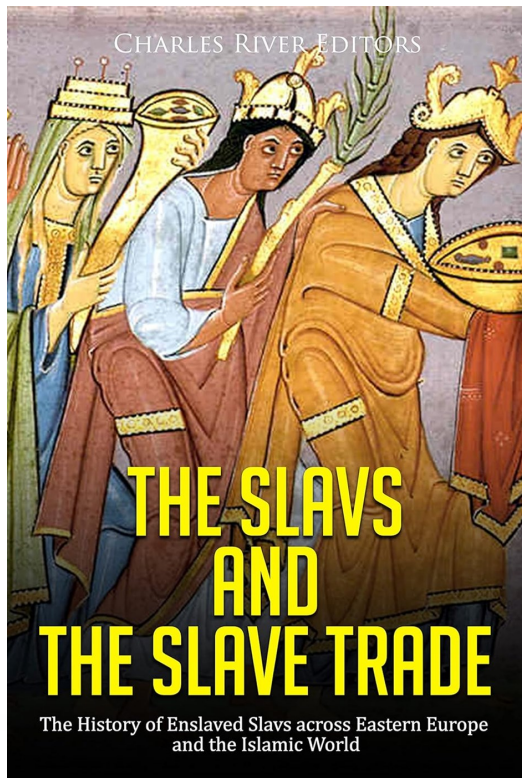

Deep-Rooted Prejudice Towards Brown Skin Based on Ancestral History

Throughout human history slavery was somewhat arbitrary, in its later forms it often had a discriminatory component, typically based on race, ethnicity, nationality or religion. This distinction shows how the practitioners of slavery justified the practice in terms of ideology, and Slavic people were discriminated against within the Ottoman Empire.

Slavs had lived in the lands of today's Eastern European region for centuries. Slavic peoples were essentially native of Eurasia and settled in the Black Sea region and other parts of today's Balkans, Eastern Europe, the Caucasus and Central Asia. One of their first major political representatives, however, was the Rus; a group that founded a settlement near today's Kiev in Ukraine. The Kievan Rus was a major regional power and they traded Slavs as slaves to the Muslims via the Volga River and the Caspian Sea.

Indeed, some historians have aligned the term Slav as deriving from descriptions of slaves: "The word "slave" and its cognates in most modern European languages is itself derived from "slavus," meaning "slav," the ethnic name for the inhabitants of this region."

Some historians have outlined how they believe that Slavic slaves were used intensively in the ninth and tenth centuries and acted as a driver of Western European economic growth and allowed Europe to "emerge from the Dark Ages."

Additionally, other scholars have asserted that Constantinople's rapid rise to become one of Europe's largest cities was fueled by a large supply of Slavic slaves.
