

He has since been able to cause more harm in my workplace by having me build up wrong incorrect car repair orders, which has resulted in the mechanics in the back doing the wrong work and not getting paid for it. So now more and more people in my workplace are yelling, snapping, and being aggressive towards me. The most recent incident was him ordering me to rush a customer and stop helping them.
