1. Purpose

2. Collection of Personal and Health Information

We collect personal and health information that is necessary to provide safe and effective psychological services. This may include:

- · your name, date of birth, and contact details;
- Medicare details
- referral information and medical or psychological history;
- · relevant personal or family information; and
- billing and payment details
- other personal details collected as part of providing counselling and mental health services.

Information is collected directly from you whenever possible. With your consent, information may also be obtained from a parent or guardian (if you are under 18 years old), referrers (such as your GP), other health professionals, or relevant third parties.

3. Credit Card Information

Credit card information may be stored securely within Zanda for billing purposes with your consent. The Worth Within does not store credit card information outside of this platform.

4. Use of Al

At The Worth Within, Heidi Al may be used to support accurate documentation of session content for clinical purposes, supervision, and ethical record-keeping. It is not used for any form of diagnostic automation, client profiling, or decision-making. You remain in full control of whether this technology is used for your sessions. You may withdraw your consent to use Heidi Al at any time by notifying your psychologist. Upon withdrawal, no further session recordings or transcriptions will be made using this platform.

5. Use and Disclosure of Information

Your personal and health information is used to:

- provide psychological assessment, treatment, and care;
- communicate with referring doctors and other treating professionals;
- manage practice administration and billing; and
- meet ethical, professional, and legal obligations.

For adolescents and individuals unable to provide informed consent, information is collected with the consent of a parent or guardian and used in accordance with this policy. Your information will not be disclosed without your consent, except where required or authorised by law — such as when there is a serious risk to your safety or the safety of others, mandatory reporting obligations, or a legal subpoena. Where possible, we will inform you before sharing information.

6. Storage and Security

In compliance with privacy law, records are retained for at least seven (7) years after your last contact, or until a person who was under 18 at the time of last contact turns 25 years old.
