## "We've done it together."

Change comes to all of our lives on a regular basis. Most of the time, we deal with it and move on. There are times, however, like dealing with the death of a loved one, an accident, or a totally traumatic event, that stop us in our tracks and may take weeks, months, or years to recover from. Dealing with COVID-19 was one of those events for many. Family, friends, neighbors and sometimes even strangers have helped us through this far and encouraged us as we've faced changes and found new paths to positively move forward.

Our Township has also experienced changes in the last few years and made difficult decisions as the world around us has changed. This township newsletter, livestreaming our town meetings on Facebook, having a township website, and our new digital sign are all examples of how we have moved into the Technological Age in an attempt to keep our residents informed of happenings. We are currently working on digitalizing all of our cemetery records so they can be accessed by the public who are either tracing family lineage or just wanting a little more knowledge about the cemetery.

Another change is the presence of Pierpont Township officials in the County meetings and offices. We have been very vocal about what Pierpont Township needs in terms of tax dollars coming back to our community. Chasing grant dollars, asking for funding, and requesting help for broadband service, road dollars, a downtown sewer system, economic development, and Veteran recognition are just a few of the topics that we have been knocking on doors about. The county recycling bins, the Dollar General Store, meetings with broadband suppliers, and requesting funds to deal with storm damaged roads are all part of your trustees' responsibilities-listening to you and speaking up on your behalf.

Our Township zoning has finally been updated thanks to the time spent and dedication of our zoning board. The new, approved document is now constitutionally sound and follows both state and federal current laws. Zoning review and revisions are ongoing processes. There are more aspects of our land uses that will need reviewed in light of the continual changes that Pierpont is experiencing. One major change is the increase in zoning fees -we cannot afford to continue using 1976 prices (just as folks building new homes are not paying 1976 lumber prices either these days).

One of the most important concepts that we have tried to encourage is the sense of community. The trustees sponsored "Celebrate Pierpont," a local showcase evening offering an opportunity for the community to meet local businesses. The Pierpont Community Action League has proactively embraced the need to support and grow local business and the Township is partnering with them to create a brochure of local businesses. Local craftsmen were hired to remodel the new Town Hall. This year a group of community volunteers have prepared and delivered "Welcome to Pierpont" baskets to new residents. In an effort to make Pierpont more attractive, the trustees have worked with homeowners to clean up a couple of burned-out properties. Each bi-monthly trustee meeting concludes by listing community events that are coming up and a calendar of events is published in our newsletter. Posters of local events can also be found in the Andover Library at Pierpont that is open each Saturday at the Pierpont Farmers Market.

The purchase of a newer small dump truck has made the cemetery work and small road jobs much less nerve racking-I had a sense of dread every time we pulled the old dump truck out of the garage. We also have purchased small power tools, road signs, and safety barriers to be used throughout the township.

There are many community members who are actively serving on committees, and many more who are quietly and faithfully seeing what needs done and doing it without fanfare or accolades (e.g., the Blood drives and those who give blood; pizza night at the fire hall; the beautification committee flowers and signs; flag placement in the downtown area; the farmers market, etc.). Thank you for what you have been doing to make Pierpont more attractive and vibrant; it is your partnership with your Trustees that is growing and strengthening our local community. Continue to reach out neighbor-to-neighbor: welcoming new ones to Pierpont Township and reaffirming and caring for our neighbors of many years.

Change can be hard to accept sometimes; it is much easier to keep doing what we've always done, rather than proactively manage change that is already here or plan for the future. Talk to your trustees about the changes you are experiencing and how together, we can address current challenges, and think forward best ways to meet future uncertainties.

#### MICRO AG LOANS for YOUNG ENTREPRENEURS

The USDA, through the Farm Service Agency (FSA), offers youth loans to establish and operate income producing projects of modest size. The loans are up to \$5,000. Project loans are available to youth participating in agriculturally focused organizations such as 4-H, FFA, and other similar organizations. Applicants must be a citizen of the US or a permanent resident between 10 and 20 years old. The loan application must include a completed farm business plan and budget signed by your project or club advisor and the approval of a parent or legal guardian. Depending on the project, size of the loan, and loan purpose, the repayment period varies from 1 to 7 years.

The FSA program notice shows a youth raising chickens to sell eggs, one who is raising a market steer, another raising a market hog, and another purchasing equipment to increase production of maple syrup. The loan purposes include buying livestock, seed, equipment and supplies, needed tools, and paying operating expenses for the project.

Requirements include a description of the agricultural project, a plan to make sufficient income to repay the loan and accrued interest, and active participation in an agricultural organization and supervised program.

#### Hello Pierpontians!

As trustees continue work on the new Town Hall, I am often asked questions about the project. One is, "what will the hall look like?" My response, "we would like to keep the New England influence of Colonial Architecture" is often met with a puzzled look. Pierpont Township, owned by the Connecticut Land Co. in 1795 was part of a region called "Western Reserve." A short article by Phillip R. Shriver on Ohio History offers insight to "New England" look called Western Reserve.

### THE WESTERN RESERVE

Visitors to northeastern Ohio are often impressed by the resemblance of this area to that of New England. Not only does the rolling land possess striking similarity, but the predominance of homes of colonial architecture and placenames such as Windsor, Deerfield, Norwalk, Ellsworth, Saybrook, New Lyme, Farmington, New London, New Milford, Hartford, New Haven, and Yale speak of the influence of New England, and particularly Connecticut, in the settlement of this region.

During the colonial period, no less than four states claimed the Ohio country — Virginia, New York, Massachusetts, and Connecticut. After independence had been won from Great Britain, New York and Massachusetts surrendered their Ohio claims to the newly established government of the United States. Virginia, however, reserved the land between the Scioto and Little Miami rivers in southern Ohio for distribution among her Revolutionary War veterans, while Connecticut stubbornly clung to a 120 - mile wide area west of Pennsylvania between Lake Erie on the north and the 41st parallel on the south. This tract of more than 3,000,000 acres Connecticut called her "Western Reserve." In 1792, the westernmost 500,000 acres of the Reserve was set aside as a special tract to be called the "Firelands," since it was to be distributed to those Connecticut families whose homes had been burned by British and Tory raids during the Revolution. Eventually some 1,870 persons received grants in the Firelands, settling principally in what are now Erie and Huron counties.

In the spring of 1795, Connecticut sold most of the remaining lands of the Western Reserve to a private speculative group called the Connecticut Land Company for \$1,200,000. Thereafter these funds were used for the support of Connecticut's public schools. It was the Connecticut Land Company which dispatched its general agent, Moses Cleaveland, and a party of surveyors to the Reserve in the spring and summer of 1796. With their coming, the first permanent settlements, Conneaut and Cleveland, were established. The Connecticut influence has persisted across northeastern Ohio to this day.

I hope you enjoyed this article on the Western Reserve as much as I did.



The Ashtabula Soil and Water Conservation district has announced their fall fish sale. The fall sale is very limited only offering Triploid White Amur and Fathead Minnows. The Amur are used to control excessive amounts of pond vegetation while the Minnows are used for baitfish. Pond conditioners and fish food are also available at this sale. It is a great time to prepare your pond for winter. The order deadline is Thursday, September 9, 2021 with delivery on Thursday September 16<sup>th</sup> between 10:30 to 11:30 at the county fairgrounds.

The spring sale orders will be due in early April. They have a wider variety of fish available then. This past spring, they had Largemouth Bass, Bluegill, Hybrid Bluegill, Shellcracker, Channel Catfish, Fathead minnows, Yellow Perch, Triploid Whit Amur, and Koi. They also had pond conditioner and fish food.
