Regular Meeting April 13, 2019

Chairman Bob Jackson called the meeting to order. The Pledge of Allegiance was recited by all in attendance.

 Rich Rea, Zoning Inspector, reported that work on the AT & T tower is started. It is located off Rt. 7 north of town on the Deeter Property.

Beautification Committee-

 Brenda Thompson with the Beautification Committee asked if the sign to Horners Woods could be taken down due to the deteriorating condition of the sign. Bob said it would be okay but requested that he would like them to help design a new sign.

Old Business

Trustee Bob Jackson reported they had 5 resumes of applicants for a new Road Supervisor. He reminded the group that the roadman needs a CDL. Bob Jackson then recommended the Tommy Lamson fill in as a part time road man at a rate of \$10/per hour. Bob Jackson made the motion to hire Tom Lamson, Grady hoover seconded the motion. Motion passed. Bob emphasized that they would be hire a new road supervisor soon, when all three trustees are present.

Grady hoover attended a recent recertification for applying chemicals. He reported that the instructor explained there should be no concern over using Round-up, therefore there is no recommendation for anything else and no problem in continuing to use Round-up.

New Business

Trustees Bob Jackson and Grady Hoover will be working alongside Tommy Lamson in repairing roads until we hire a new roadman.

It was announced that this month is the last month for Saturday morning meetings. Beginning in May, the meetings will once again be held on the $1^{\rm st}$ and $3^{\rm rd}$ Tuesdays at 6:00 pm. Bob Jackson will take care of having the notice changed in the newspaper.

Alvin Williams asked if it would be possible to turn over the entire amount of the levy funds brought in by the levy. The levy monies are exclusively dedicated for the fire department. In the past, the contract has stated a set amount. Some townships have had the problems holding carryovers. Bob made a motion for future contracts with the fire department to turn over all the monies the levy brings in. Grady Hoover seconded the motion. Motion carried. A resolution will need to be written in this regard.

Bob stated that the trustees are aware that there are potholes but they are getting to them. Grady said they would be using 304 (crushed concrete) on the road where needed. No new material has been put on

the roads. The materials that is being seen is stone that was already there in the berm. It is just being relocated as the road maintenance is being done.

- Lena Gallagher asked about the trees that were uprooted due to the Lewis Road ditching program. Trustee Jackson stated that it is the landowner's responsibility to clean-up the trees. The ditching program will resume when the weather permits.

A new road supervisor was discussed and want to hire David Smith, a retired road man from Denmark Township, for \$17.50 per hour and waived health benefits. Barb motioned to hire David Smith for \$17.50 per hour as Pierpont Township's Road Supervisor. Bob seconded the motion.

Three people were hired (Dave Carr, Rita Carr, and Steve Koivisto) to mow the cemetery and they started on April 24, 2019. Some stones have fallen over and some new footers need placed.

NOPEC has a community grant for \$250 that the township is applying for. Barb motioned to apply for the grant and Bob seconded the motion.

The garage door opener broke in the garage and is in need of repair. Babb's Overhead Door out of Williamsfield was suggested to do the repair. Bob motioned to hire Babb's and Grady seconded the motion.
