Vendors should remain set up during the event, however vendors reserve the right to remove items from display, when not present. If the vendor is selling items of value, this is recommended. Weekly vendors may begin to breakdown at 4:00pm on the last day of the sale and should be completed with breakdown by 6:20pm. Daily vendor should be completed within 30 minutes of the event closing schedule. Electricity is generally not provided. If you need electricity, please contact us, and we will determine if the accommodation can be made. Refunds are only provided if the event is cancelled. Cause for event cancellation would consist of a National/State Disaster that would require the event location to revert to an emergency shelter, etc. Carolina Kids Consignment will issue full refund of amount paid. Carolina Kids Consignment does not assume any additional liability for expenses incurred by individual or business renting the space.
