Expunge Colorado is a women/BIPOC-led 501(c)(3) nonprofit organization, dedicated to increasing access to record sealing through education and pro-bono legal services.

We believe that sealing eligible criminal records from public view helps restore economic opportunities, justice, and dignity to people deserving of a fresh start.

Expunge Colorado strives to provide meaningful change to individuals who have been negatively impacted by a criminal record. To do this, we offer events and education focused on record sealing.

Our annual sealing events provide pro bono legal services for the purposes of clearly determining eligibility for record sealing for attendees. If a constituent has eligible charges that can be sealed, they receive legal representation and financial assistance through all stages of their case(s).

To maximize impact, we also work to de-stigmatize having a criminal record through the creation of record-sealing education for the general public and by supporting legislation that automates record-sealing and expands eligibility.

### **OUR WORK OVER THE YEARS**







- Since 2018, we have hosted five annual clinics free of charge for the community
- Reviewed over 500 records for eligibility | Sealed approximately 140 records from public view
- Recruit and train 100+ lawyers/law students/paralegals offering CLE credit for legal volunteers
- Worked with more than 25 organizations to provide wrap-around services at events
- Support the passage and implementation of Clean Slate legislation (SB21-99 Auto Record Sealing)

#### Passage of SB-22-099 - Clean Slate Act

- Clean Slate Coalition member/strategic partner assisting in the passage and implementation of the Clean Slate Act
- Wrote specific legislation ensuring petitioners can file municipal petitions to seal in the municipality where the case occurred (as opposed to paying to create a new, separate case) (C.R.S. 24-72-708)
- Testified in Senate and House hearings in support of SB22-99
- Attended and spoke at Business Support Press Release
- Presented CLE's to Denver Bar Association -Young Lawyers Division and 1st Judicial District Bar Association on implementation
- 7th state in the country to pass automated Clean Slate legislation


#### **Expunge Colorado sealed:**

- A total of 45 records
- Nearly as many convictions and non-convictions
- Records in 10 Colorado counties


#### Of the 45 records sealed:

- 21 are conviction records
- 24 are non-conviction records
- 13 people had multiple records sealed
- 32 individuals had records sealed
- Average Age of Petitioner: 44.6 years old
- Average Age of Case: 14.5 years old

#### Records Sealed By County




#### Convictions Sealed: What Level






#### Category of Conviction Sealed




### CLINIC ATTENDEE DEMOGRAPHICS (SELF-IDENTIFIED)















#### All Attendees received the following at 2022 Clinic:

- · Welcome Packet
- Review of record by a licensed attorney
- Form filed out by attorney explaining why they are not eligible or, if applicable, at what date in the future they will be eligible
- Municipal forms and instructions how to seal a municipal record, if applicable
- Referral to Turn Over the New Leaf for eligible municipal marijuana records
- Entered into Expunge Colorado's "Eligibility Tracker" if a case may be eligible in the future, for potential follow-up



#### **Improvements in our Intake Process:**

Every attendee met with a volunteer who gathered information needed to pull records. Upon intake, clinic attendees were provided a Welcome packet with the following:

- Clinic process FAQ on what to expect for the day
- About Us Expunge Colorado Overview
- General eligibility information
- Offer for SNAP recipients to receive \$250 stipend from CrossPurpose
- · Overview flier of Clean Slate law on automatic record sealing
- · Re-entry community resources

#### General Conviction Eligibility Guide

Below are general guidelines on what convictions are eligible to be sealed. The conviction offense level should be identifiable on a criminal background report. However, determining if a conviction is eligible to be sealed can be a complex. long process. At today's clinic, volunteer attorneys are trained to help make that determination. We appreciate your patience with us. Thank you for being here.

List of Eligible Convictions By Offense Level	Waiting Time Before Eligible (start from end date of probation/parole supervision)
Civil Infraction/Petty Offense/ Drug Petty Offense	1 year
M2 / M3 / Drug Misdemeanor / DF4 for 18-18-403.5(2.5)	2 years
F4 / F5 / F6 / DF3 / DF4 / M1	3 years
All other eligible convictions	5 years

#### **Ineligible Convictions**

\*Not a Comprehensive List\*

- · Class 1, 2, A and B traffic offenses
- DUI and DWAI
- F1 / F2 / F3 / DF1 level convictions
- · Domestic violence crimes
- · Unlawful sexual behavior crimes
- · Crimes of Violence ("COV")
- Child Abuse
- · Identity Theft
- · Felony cruelty to animals
- · Any federal or out of state cases

#### Reasons for Record Sealing Ineligibility at the Clinic:

- Owes Restitution
- · Active criminal case
- Level of charge not eligible
- · Has not waiting the required amount of time
- · New convictions on record that prevent sealing of prior ones

#### **Behind the Scenes Post-Clinic**

Follow up activities continue on for many months after the clinic.
Attorney volunteers only determine eligibility for attendees.
After the clinic, Expunge Colorado's Chief Legal Officer takes responsibility for the case by:

- Supervising all eligibility determinations
- Hosting follow-up attorney volunteer night to review outstanding cases
- Referring paperwork to the paralegal team to complete forms
- · Communicating with petitioners regarding eligibility
- Sending Docusign links to petitioners with eligible cases
- Filing petitions to seal and proposed orders (x3) for every eligible case
- Following up with the court regarding delays
- · Attended hearings and assisted petitioners in preparation for court
  - 2 in-person hearings
  - 5 virtual hearings
- Arguing interpretation of case law question whether to determine drug offense by today's classification
- Once sealed, sending Order to Seal to CBI and paying required fees
- Sending Order to Seal to petitioner





Under the direction and supervision of Expunge Colorado's Chief Legal Officer, Abbey Moffitt, an analysis of cases was done alongside Colorado Center for Law and Policy's legal fellow to see if statutory requirements are being met and if cases are actually being sealed.

Key Findings were determined after running a random sample of cases successfully sealed at the 2022 clinic:

#### **CBI, Colorado Bureau of Investigations**

- CBI continues to charge a \$20 processing fee to seal non-conviction cases when the Order to Seal comes from the defendant rather than the court.
   CBI was required to seal non-conviction records at no cost beginning August 2022 as noted in SB22-099.
- Arrest records that are sealed through CO Courts are not showing up as sealed in CBI. It should be cleared in both databases.


#### **CO COURTS**

This list is not comprehensive. We have identified 14 separate issues that prevent the successful sealing of cases.

- · Fees are being charged in non-conviction cases by the courts.
- One Judge denied a motion to seal because the defendant owed outstanding fees and costs, despite the law change.
- Courts setting hearings on 24-72-705 motions despite it not being authorized by law.
- · Courts denying the ability to appear virtually.
- Older cases require having to call the clerk's office to have them open the case in the electronic system.
- Courts never issuing an Order, to any degree in a case, and having to file a request for ruling.
- Law enforcement agencies do not have an electronic mailing address to send the Order to, and neither does State Court Adminstrator's Office





- Create educational videos to be shared via
   Website and Social Media about record sealing laws, processes
- Create a survey to better understand the needs of the justice-impacted community and provide education around those needs


