Ending Subminimum Wages: Passage of a Bill to End 14(c) Certificates

For advocacy related to ending the use of **14(c) certificates** in Georgia, which allows organizations to pay people with disabilities below minimum wage, the following legislative committees are most relevant:

- House Industry and Labor Committee: This committee addresses labor and management relations, including wage-related legislation. They will have to consider a bill to end subminimum wages.
- House Special Committee on Health Care: This committee might address related employment issues for people with IDD as part of broader healthcare and support systems discussions.
- House Small Business Development Committee: This committee could be involved in discussions about transitioning businesses that rely on subminimum wages to fair employment practices.
- Senate Insurance and Labor Committee: With jurisdiction over labor issues, this committee would review legislation aimed at eliminating subminimum wage practices.
- Senate Insurance and Labor Committee: Reviews labor issues, including wage-related policies. It would be a key committee for advocating for the elimination of 14(c) certificates.
- Senate Health and Human Services: Focuses on legislation related to public welfare, including fair employment practices for people with disabilities.
- House and Senate Economic Development and Tourism Committees: These committees might review the economic impact of ending subminimum wages and consider policies to support businesses employing people with IDD.

Inclusive Post Secondary Education (IPSE)

The House Higher Education Committee would be most relevant to advocate for and thank legislators for their continued support and expansion of inclusive post-secondary education (IPSE) programs in Georgia. This committee is directly responsible for legislation related to colleges and universities. It plays a key role in ensuring that funding and policies support IPSE programs.
