

Anne Stava's House "YES" Votes from Year 2019 thru 2024 - with commentary by *Laura Hois*

- SB 1474** Passed April 10, 2019 - allows labor unions to mandate membership in their unions. *Took power away from local government and put it into the hands of state labor unions.*
- HB 1637** Passed May 27, 2019 - disallows law enforcement agencies from working with immigration and customs enforcement (ICE). *Encouraged illegal immigration, protects illegal aliens.*
- SB 1784** Passed October 29, 2019 - mandates employers and unions to provide list of public employees every month to coerce workers to join union. *Prohibited employers from discouraging unions.*
- HB 3994** Passed March 4, 2020 - makes massive changes to the voting system, establishing curbside voting and pushing vote by mail. *Enabled massive voter fraud and disenfranchised voters.*
- SB 818** Passed May 28, 2021 - makes Illinois the first state to implement sex-education that aligns with the *extremely explicit and perverse* National Sex Education Standards (NSES).
- HB 562** Passed June 16, 2021 - firearm owners who voluntarily submit fingerprints with FOID renewal skip ahead of those who choose not to submit fingerprints. *Violates 2nd Amendment rights.*
- HB 2782** Passed March 23, 2023 - mandates investment managers to annually disclose how to incorporate sustainability factors in decision-making processes. *Unnecessary, costly regulation.*
- SB 40** House passed May 4, 2023 - provides a new single-family residence or multifamily shall have have an electric-vehicle capable parking space for each unit. *More costly government overreach.*
- SB 1909** House passed May 10, 2023 - prohibits pro-life pregnancy centers from using "unfair" competition or "deceptive" practices to prevent individuals from accessing services. *Unconstitutional.*
- SB 3865** Passed April 7, 2022 - removes "dehumanizing term 'alien'" from Illinois statutes. *Ridiculous.*
- HB 2528** Passed March 21, 2023 - requires Board of Higher Education to establish a hunger-free campus grants. *Taxpayers should not have to subsidize food for college students; should pay for their own food.*
- HB 3491** Passed March 22, 2023 - grants laborers, workers or mechanics right to sue if they are paid less than prevailing wage rates for work on project. *Substantially increased construction costs.*
- HB 606** House adopted April 30, 2024 - declares March 12 "Equal Pay Day" in Illinois, encourages citizens to learn about the pay gap women experience in society. *2nd wave feminist, LGBTQ+ nonsense.*
- SB 1** House passed May 9, 2024 - created Dept of Early Childhood "centralizing all education, care programs/services into a single State agency." *Social welfare is not the role of government.*
- SB 3597** House passed May 21, 2024 - allows local governments to obtain loans from Climate Bank to to purchase real estate for "clean energy infrastructure." *Robs taxpayers. Climate change hoax.*
- SB3762** House passed May 23, 2024 - Language equity multilingual policy increases taxes. *Extremely expensive, subverts our culture, is an existential threat to America's heritage and unity as "one nation."*
