

BYLAWS OF WILLOWSTONE HOMEOWNERS ASSOCIATION, INC.

ARTICLE I OFFICES

Willowstone Homeowners Association, Inc., (the "Association") is a Colorado nonprofit corporation, with its principal office located at 30 Benchmark Road, Suite 222, Avon, Colorado, 81620, and with a mailing address of P. O. Box 5570, Avon, Colorado, 81620. The Association may also have other offices and may carry on its purposes at such other places within and outside the State of Colorado as the Board may from time to time determine.

ARTICLE II DEFINITIONS AND ASSENT

- 2.1 <u>Definitions</u>. The definitions in Article III of the Amended and Restated Covenants of Covenants, Easements and Restrictions of Eagle River Estates, Filing 4, also referred to as Willowstone ("Covenants"), as amended from time to time and recorded in the office of the Clerk and Recorder of Eagle County, Colorado, shall apply to these Bylaws, and all defined terms used in the Bylaws shall have the same meaning as defined terms used in the Covenants.
- 2.2 <u>Assent</u>. All present or future Owners, their families, present or future tenants, and their guests and invitees are subject to the Association Documents, including these Bylaws. The acquisition of any of the Lots in Willowstone or the occupancy of any residence located thereon shall constitute ratification and acceptance of these Bylaws.

ARTICLE III MEMBERSHIP, VOTING, QUORUM AND PROXIES

- 3.1 Membership and Voting. The Association shall be a membership corporation without certificates or shares of stock. The Association shall have one (1) class of voting membership. Members shall be all Owners and the Declarant, as defined in the Covenants, and shall be entitled to vote in Association matters pursuant to the Covenants on the basis of the following: one vote for each Lot owned. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised by one person or alternative persons appointed by proxy in accordance with the Bylaws. In the absence of a proxy, the vote allocated to the Lot shall be suspended in the event more than one person or entity seeks to exercise the right to vote on any one matter. Any Owner of a Lot who desires to assign his voting right to an alternative person must provide a proxy appointing the alternative person to the Secretary of the Association prior to any meeting in which the alternative person exercises the voting right. Declarant shall be entitled to one vote for each Lot owned.
- 3.2 <u>Election of Directors</u>. In the election of Directors, each Member shall have the right to vote the number of votes to which he is entitled for as many persons as there are

Directors to be elected, and for whose election he is entitled to vote. Cumulative voting shall not be allowed.

- 3.3 Quorum. Except as otherwise provided in these Bylaws or in the Covenants, the presence in person or by proxy of a majority of the votes entitled to be cast at such meeting shall constitute a quorum.
- 3.4 <u>Majority Vote</u>. Unless a different percentage is required by law, the Covenants, the Articles of Incorporation or these Bylaws, the affirmative votes of more than a majority of the members present of the votes represented at a meeting duly called and convened at which a quorum is present shall be sufficient to adopt decisions binding on all Members.

ARTICLE IV MEETINGS

- 4.1 <u>Annual Meeting</u>. The first annual meeting of the Members shall be held within one year from the date of incorporation of the Association, and each subsequent regular annual meeting of the Members shall be held on a date and at a time selected by the Board of Directors in each succeeding year.
- 4.2 <u>Special Meeting.</u> Special meetings of the Members for any purpose other than those regulated by statute shall be called by the President of the Association, either upon resolution of the Executive Board, or by petition of owners representing the Owners of at least fifty percent (50%) of the Lots.
- 4.3 <u>Notice of Meeting</u>. The President or Secretary shall give, or cause to be given, written notice of the time, please and purpose of each annual or special meeting by mailing, postage prepaid, or hand-delivering such notice at least ten (10) days, but not more than fifty (50) days, prior to such meeting to each Member of the Association at the address of each such Member that appears in the records of the Association. The Executive Board may set a record date for determination of Members entitled to notice of and to vote at a meeting.
- 4.4 <u>Adjourned Meetings</u>. If, at the time and place of meeting, a quorum is lacking, the chairman of the meeting, or the members holding a majority of the votes present in person or by proxy, may adjourn the meeting from time to time until a quorum exists. At any adjourned meeting at which a quorum exists, any business may be transacted which might have been transacted at the original meeting.
- 4.5 <u>Waiver of Notice</u>. Any Member may at any time waive any notice required to be given under these Bylaws, by statute or otherwise. The presence of a member in person at any meeting of the members shall constitute a waiver, unless such presence is for the express purpose of objecting to the meeting for the reason that it was not lawfully called.
- 4.6 <u>Place of Meetings</u>. A waiver of notice signed by all Members entitled to vote at a meeting may designate any place, either within or outside Colorado, as the place for such meeting.

If there is no such waiver, the place for annual and special meetings shall be the principal office of the Association.

- Action of Members Without a Meeting. Any action required to be taken or which may be taken at a meeting of the Members may be taken without a meeting if a consent in writing, setting forth the action so taken, is signed by all of the Members entitled to vote with respect to such action.
- 4.8 Order of Business. The order of business at all meetings of Members shall be as follows:
 - a) Roll call:
 - b) Statement of compliance with procedures for notice of meeting or waiver of notice:
 - Reading of minutes; c)
 - d) Reports of officers;
 - Reports of committees: e)
 - Election of Directors (annual meetings only); f)
 - Unfinished business: g)
 - h) New business; and
 - i) Adjournment.
- 4.9 Rules of Meetings. The Executive Board may prescribe reasonable rules for the conduct of all meetings of the Executive Board and members and in the absence of such rules, Robert's Rules of Order shall be used.

ARTICLE V **EXECUTIVE BOARD**

- Association Responsibilities. The Owners will constitute the Association, who will have the responsibility of administering to the Property through an Executive Board. In the event of any dispute or disagreement between any owners relating to the Property, or any questions of interpretation or application of the provisions of the Covenants or Bylaws, such dispute or disagreement shall be submitted to the Board. the determination of such dispute or disagreement by the Board shall be binding on all such Owners, subject to the right of Owners to seek other remedies provided by law after such determination by the Board.
- 5.2 Number and Initial Board. The affairs of this Association shall initially be managed by an Executive Board of three (3) Directors who shall be appointed by the Declarant as provided in Section 5.3 below. After expiration of the period of Declarant Control, the number of the Executive Board shall be three or as established from time to time by amendment to these Bylaws.
- Directors During Declarant Control. Declarant and any successor of Declarant who takes title to all or part of the Property for the purpose of development and sale of the Property and who is designated as Successor Declarant in a recorded instrument executed by



Declarant shall have exclusive power to appoint and remove members of the Executive Board and officers of the Association. This period of Declarant control shall terminate sixty (60) days after conveyance of 90% of the Lots, including those that may be created, to Lot Owners other than Declarant. Declarant may voluntarily surrender the right to appoint and remove officers and members of the executive Board before termination of the period of Declarant control, but, in that event, the Declarant may require for the duration of the period of Declarant control, that specified actions of the Association or the Executive Board, as described in a recorded instrument by the Declarant, be approved by the Declarant before they become effective. The Directors selected by Declarant need not be Members of the Association.

- 5.4 Election of Directors During Members' Control. At the first meeting of the Members, after the Declarant no longer appoints the Executive Board, the Members shall elect a new Executive Board, and any terms of Directors which have not expired shall immediately terminate. Directors shall be elected by the members at each annual meeting of the Members. At the first general election of the Board by Association Members and subsequent elections, the Members of the Association may cast as many votes as they are entitled to exercise under the provision of Section 3.1 above. Voting for Directors shall be by secret written ballot.
- 5.5 Term of Office of Directors during Members' Control. The term of office for the initial Directors shall be fixed at the time of their election as they themselves shall determine in order to establish a system of three (3) year terms in which at least one-third (1/3) of the Board is elected each year, and the Board shall identify in which year the directorships for each category of representation are subject to election. For example, if the number of Directors on the initial Board is set at three (3), one (1) Director shall serve for a one (1) year term, one (1) Director shall serve for a three (3) year term. At the expiration of the initial term of office of each respective Director, a successor shall be elected to serve three (3) years. Each Director shall hold office until his successor is elected by the Association and qualified.
- 5.6 <u>Removal of Directors, Vacancies</u>. Directors may be removed and vacancies on the Board may be filled as follows:
- (a) By the Members. Any Director may be removed, with or without cause, at any regular or special meeting of the Members by a majority of votes of the Members entitled to vote for a successor. A successor to any Director removed may be elected at such meeting to fill the vacancy created by removal of the Director. A Director whose removal is proposed by the Members shall be given notice of the proposed removal at least ten (10) days prior to the date of such meeting and shall be given an opportunity to be heard at such meeting.
- (b) By the Board. Any Director who has three (3) consecutive unexcused absences from Board meetings or who is delinquent in the payment of any assessment for more than thirty (30) days may be removed by a majority vote of the Directors present at a regular or special meeting at which a quorum is present, and a successor may be appointed by the Board. In the event of the death, disability, resignation or removal by the Board, as set forth in this subsection (b), of a Director, a vacancy may be declared by the Board, and the Board may appoint a

successor. Any successor appointed by the Board shall serve for the remainder of the term of the Director replaced.

- 5.7 <u>Powers and Duties</u>. The Executive Board shall have the powers and duties necessary for the administration of the affairs of the Association and for the operation and maintenance of a first class residential project. The Executive Board may do all such acts and things as are not by law, the Articles, these Bylaws or the Covenants either prohibited or directed to be exercised and done by the Owners.
- 5.8 Other Power and Duties. The Executive Board shall be empowered and shall have the duties as follows:
- a) to administer and enforce the covenants, conditions, restrictions, limitations, obligations and all other provisions set forth in the Covenants and in the Articles and these Bylaws;
- b) to establish, make and enforce compliance with such reasonable rules and regulations as may be necessary for the operation, use and occupancy of the Lots and the Common Area with the right to amend same from time to time. A copy of such rules and regulations shall be delivered or mailed to each owner promptly upon the adoption thereof,

- c) to keep in good order, condition and repair the Common Area, and all items of personal property, if any, used in the enjoyment of the property;
- d) to obtain and maintain to the extent obtainable all policies of insurance required by the Covenants;
- e) to periodically fix, determine, levy and collect the Assessments to be paid by each of the Owners toward the Common Expenses of the Association and to adjust, decrease or increase the amount of the Assessments, refund any excess Assessments to the owners or to credit any excess of Assessments over expenses and cash reserves to the Owners against the next succeeding assessment period. To the extent permitted by law, levy and collect Special Assessments in accordance with the provisions of the Covenants, whenever in the opinion of the Board it is necessary to do so in order to meet increased operating or maintenance expenses or costs, or additional capital expenses, or because of emergencies. All Special Assessments shall be in statement form and set forth in detail the various expenses for which the Assessments are being made;
- f) to impose penalties and collect delinquent Assessments by suit or otherwise, to collect costs and reasonable attorney's fees, and to enjoin or seek damages from an Owner as is provided in the Covenants;
 - g) to protect and defend the Property from loss and damage by suit or otherwise;

- h) to borrow funds and to give security therefor in order to pay for any expenditure or outlay required pursuant to the authority granted by the provisions of the Covenants or these Bylaws and to execute all such instruments evidencing such indebtedness as the Executive Board may deem necessary or desirable;
- i) to enter into contracts within the scope of their duties and powers, provided however, that any agreement for management of the Property, or any other contract providing for services of the Declarant may not exceed one (1) year, and any such agreement must provide for termination by either party without cause and without payment of a termination fee on no more than one hundred eighty (180) days written notice;
- j) to establish bank accounts which are interest-bearing or non-interest bearing, as may be deemed advisable by the Executive Board;
- k) to keep and maintain detailed, full and accurate books and records showing in chronological order all of the receipts, expenses or disbursements pursuant to appropriate specificity and itemization and to permit inspection thereof as is provided in the Covenants and these Bylaws and, upon the vote of Owners representing the Owners of two-thirds (2/3) of the Lots, to cause a complete audit to be made of the books and records by a competent certified public accountant;
- l) to designate and remove the personnel necessary for the operation, maintenance, repair and replacement of the Common Area;
- m) to suspend the voting rights of an Owner for failure to comply with these Bylaws or the rules and regulations of the Association or with any other obligations of the Owners pursuant to the Covenants;
- n) to buy or otherwise acquire, sell or otherwise dispose of, mortgage or otherwise encumber, exchange, lease, hold, use, operate and otherwise deal with and in, real, personal and mixed property of all kinds, and any right or interest therein, for any purpose of the Association, subject to the Covenants and Bylaws of the Association;
- o) in general, to carry on the administration of the Association and to do all of those things necessary and/or desirable in order to carry out the governing and operating of the Property.
- 5.9 <u>Maintenance Manager</u>. The Executive Board may employ for the Association a Maintenance Manager (at a compensation established by the Executive Board) to perform such duties and services as it shall authorize. The Executive Board may delegate any of the powers and duties granted to it but, notwithstanding such delegation, shall not be relieved of its responsibility under the Covenants, the Articles or these Bylaws.
- 5.10 <u>Regular Meetings</u>. Regular meetings of the Executive Board may be held at such time and place as shall be determined, from time to time, by a majority of the Directors, but at

least two (2) such meetings shall be held each year. Notice of regular meetings of the Executive Board shall be given to each Director, personally or by mail, telephone or telegraph, at least three (3) days prior to the day named for such meeting.

- 5.11 Special Meetings. Special meetings of the Executive Board may be called by the President, or his own initiative, on three (3) days notice to each Director, given personally, or by mail, telephone or telegraph, which notice shall set forth the time, place and purpose of the meeting. Special meetings of the Executive Board shall be called by the President or Secretary in like manner and on like notice on receipt of a written request to call such a special meeting from at least two (2) Directors.
- 5.12 Waiver of Notice. Before or at any meeting of the Executive Board, any Director may, in writing, waive notice of such meeting and such waiver shall be deemed equivalent to giving such notice. Attendance by a Director at any meeting of the Board shall be a waiver of notice by him of the time and place thereof. If all the Directors are present at any meeting of the Board, no notice shall be required and any business may be transacted at such meeting.
- 5.13 Executive Board's Quorum. At all Executive Board meetings, a majority of the Directors shall constitute a quorum to transact business, and the acts of the majority of the Directors present at a meeting at which a quorum is present shall be the acts of the Executive Board. If at any meeting of the Executive Board there is less than a quorum present, the majority of those present may adjourn the meeting from time to time for periods of no longer than one (1) week until a quorum is obtained or until a conclusion can be reached. At any such adjourned meeting, any business which might have been transacted at the meeting as originally called may be transacted without further notice.
- 5.14 Compensation, Fidelity Bonds. The members of the Executive Board shall serve without salary or compensation. The Executive Board may require that all officers and employees of the Association handling or responsible for Association funds shall furnish adequate fidelity bonds. The premiums on such bonds shall be paid by the Association.
- 5.15 Informal Action by Directors. Any action required or permitted to be taken at a meeting of the Directors may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all of the Directors entitled to vote with respect to the subject matter thereof. Such consent shall have the same force and effect as the unanimous vote of the Directors.
- 5.16 Teleconference Meetings. Any regular or special meeting of the Board may be conducted by teleconference, followed by minutes of such meeting, which shall be distributed to each Director.

ARTICLE VI OFFICERS



- 6.1 General. The officers of the Association (who shall be elected from among the members of the Board) shall be a President, one or more Vice-Presidents, a Secretary, and a Treasurer. The officers shall be elected by an affirmative vote of a majority of the members of the Board. The Board may elect such other officers, assistant officers, committees and agents, including Assistant Secretaries and Assistant Treasurers, as they may consider necessary or advisable, who shall be chosen in such manner and hold their offices for such terms and have such authority and duties as from time to time may be determined by the Board. One (1) person may hold two (2) offices. In all cases where the duties of any officer, agent or employee are not prescribed by the Bylaws or by the Board, such officer, agent or employee shall follow the orders and instructions of the President.
- 6.2 <u>Removal of Officers</u>. Upon an affirmative vote of a majority of the members of any Board, any officer may be removed, either with or without cause, and his successor elected at any regular meeting of the Board, or at any special meeting of the Board called for such purpose.
- 6.3 <u>Vacancies</u>. A vacancy in any office, however occurring, may be filled by an affirmative vote of a majority of the members of the Board for the unexpired portion of the term.
- 6.4 <u>President</u>. The President shall be the chief executive officer of the Association. He shall preside at all meetings of the Association and of the Board. He shall have the general and active control of the affairs and business of the Association and general supervision of its officers, agents and employees. The President has the authority to prepare, execute, certify and record documents reflecting amendment to the Covenants which are properly amended pursuant to the provisions of the Covenants.
- 6.5 <u>Vice-President</u>. The Vice-Presidents shall assist the president and shall perform such duties as may be assigned to them by the President or by the Board. In the absence of the President, the Vice-President elected by the Board shall have the powers and perform the duties of the President.
- 6.6 Secretary. The Secretary shall keep the minutes of the proceedings of the Members, executive committee and the Board. He shall see that all notices are duly given in accordance with the provisions of these Bylaws, the Covenants and as required by law. He shall be custodian of the corporate records and of the seal of the Association and affix the seal to all documents when authorized by the Board. He shall keep at its registered office or principal place of business within or outside Colorado a record containing the names and registered addresses of all Members, the designation of the Lot owned by each Member, and, if such Lot is mortgaged, the name and address of each Mortgagee. He shall, in general, perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned to him by the President or by the Board. Assistant Secretaries, if any, shall have the same duties and powers, subject to supervision by the Secretary.

6.7. Treasurer. The Treasurer shall be the principal financial officer of the Association and shall have the care and custody of all funds, securities, evidences of indebtedness and other personal property of the Association and shall deposit the same in accordance with the instructions of the Board. He shall receive and give receipts and acquittances for monies paid in on account of the Association, and shall pay out of the funds on hand all bills, payrolls and other just debts of the Association of whatever nature upon maturity. He shall perform all other duties incident to the office of the Treasurer and, upon request of the Board, shall make such reports to it as may be required at any time. He shall, if required by the Board, give the Association a bond in such sums and with such sureties as shall be satisfactory to the Board, conditioned upon the faithful performance of his duties and for the restoration to the Association of all books, papers, vouchers, money and other property of whatever kind in his possession or under his control belonging to the Association. He shall have such other powers and perform such other duties as may be from time to time prescribed by the Board or the President. The Assistant Treasurers, if any, shall have the same powers and duties, subject to the supervision of the Treasurer.

ARTICLE VII INDEMNIFICATION

- 7.1 <u>Definitions</u>. For purposes of this Article VII, the following terms shall have the meanings set forth below:
- (a) <u>Proceedings</u>. Any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative and whether formal or informal;
- (b) <u>Indemnified Party</u>. Any person who is or was a party or is threatened to be made a party to any Proceeding by reason of the fact that he is or was a Director or officer of the Association or, while a Director or officer of the Association, is or was serving at the request of the Association as a Director, officer, partner, trustee, employee or agent of another corporation, partnership, joint venture, trust or other enterprise including, without limitation, any employee benefit plan of the Association for which any such person is or was serving as a trustee, plan administrator or other fiduciary.
- 7.2 <u>Indemnification</u>. The Association shall indemnify any Indemnified Party in any Proceeding to the fullest extent permitted by law.
- 7.3 <u>Insurance</u>. By action of the Board, notwithstanding any interest of the Directors in such action, the Association may purchase and maintain insurance, in such amounts as the Board may deem appropriate, on behalf of any Indemnified Party against any liability asserted against him and incurred by him in his capacity of or arising out of his status as an Indemnified Party, whether or not the Association would have the power to indemnify him against such liability under applicable provisions of law.
- 7.4 Right to Impose Conditions to Indemnification. The Association shall have the right to impose, as conditions to any indemnification provided or permitted in this Article VII, such reasonable requirements and conditions as to the Board may appear appropriate in each specific

case and circumstances including, without limitation, any one or more of the following; a) that any counsel representing the person to be indemnified in connection with the defense or settlement of any Proceeding shall be counsel mutually agreeable to the person to be indemnified and to the Association; b) that the Association shall have the right, at its option, to assume and control the defense or settlement of any claim or proceeding made, initiated or threatened against the person to be indemnified; and c) that the Association shall be subrogated, to the extent of any payments made by way of indemnification, to all of the indemnified person's rights of recovery, and that the person to be indemnified shall execute all writings and do everything necessary to assure such rights of subrogation to the Association.

ARTICLE VIII AMENDMENT OF BYLAWS

- 8.1 Amendment by the Members. These Bylaws may be amended by the affirmative vote of at least seventy-five percent (75%) of the votes in the Association present or represented by proxy at any regular or special meeting, provided a quorum is present at such meeting. However, notwithstanding the foregoing, no provisions of these Bylaws may be amended by a number of Owners which is less than the number of Owners required within that particular provision to take certain action. Amendments may be proposed by the Executive Board or by petition signed by the holders of at least a majority of the votes. A statement of any proposed amendment shall accompany the notice of any regular or special meeting at which such proposed amendment will be voted upon.
- 8.2 Amendment by the Board. The Board may amend these Bylaws by unanimous vote at any regular or special meeting, provided a quorum is present at such meeting. A statement of any proposed amendment shall accompany the notice of any regular or special Board meeting at which such proposed amendment will be voted upon.
- 8.3 <u>Scope of Amendments</u>. These Bylaws may not be amended in a manner inconsistent with the Articles of Incorporation of the Association, the Covenants, or Colorado law.

ARTICLE IX CORPORATE SEAL

The Executive Board may obtain a suitable corporate seal containing the name of the Association, which seal shall be in the custody and control of the Secretary. If and when so directed by the Executive Board, a duplicate seal may be kept and used by such officer or other person as the Executive Board may name.

ARTICLE X MISCELLANEOUS

10.1 Registration of Mailing Address. If a Lot is owned by two (2) or more Owners, such co-owners shall designate one (1) address as the registered address required by the Covenants and shall designate the "voting member." An owner or Owners shall notify the

Secretary of his or their a) registered address within five (5) days after any transfer of title or change of address, and b) "voting member" within five (5) days after any transfer of title or to designation thereof. Such notice shall be written and signed by all of the Owners to which it relates or by such persons authorized to sign on behalf of such Owners.

- 10.2 <u>Notice to Association</u>. Every Owner shall timely notify the Association of the name and address of any Mortgagee, purchaser, transferee or lessee of his Home. The Association shall maintain such information at the office of the Association.
- 10.3 <u>Proof of Ownership</u>. Except for those Owners who initially purchase a Lot from Declarant, every person becoming an Owner shall immediately furnish to the Executive Board a photocopy or a certified copy of the recorded instrument vesting in that person such ownership, which instrument shall remain in the files of the Association. A Member shall not be deemed to be in good standing nor shall he be entitled to vote at any annual or special meeting of Members unless this requirement is first met.
- 10.4 <u>Character of Association</u>. The Association is not organized for profit. No member, member of the Executive Board, officer or person for whom the Association may receive any property or funds shall receive any pecuniary profit from the operation thereof, and in no event shall any part, of the funds or assets of the Association be paid as salary or compensation to, or distributed to, or inure to the benefit of, any of the Executive Board, officers or Members, except upon a dissolution of the Association, provided, however, (1) that reasonable compensation may be paid to any Member, Manager, Director, or officer while acting as an agent or employee of the Association for service rendered in effecting one or more of the purposes of the Association, and (2) that any Member, Manager, Director, or officer may, from time to time, be reimbursed for his actual and reasonable expenses incurred in connection with the administration of the affairs of the Association.
- 10.5 <u>Right of Entry</u>. The Manager and any person authorized by the Board shall have the right to enter each Lot in case of any emergency originating in or threatening such Home whether or not the Owner or occupant is present at the time. Such authorized persons shall also have the right to enter each Lot to perform maintenance and repair work as prescribed by these Bylaws and the Covenants.
- 10.6 <u>Fiscal Year</u>. The fiscal year of the Association shall be determined by the Executive Board and shall be subject to change by the Executive Board as necessary.
- 10.7 <u>Budget</u>. At each annual meeting of the Executive Board, the Executive Board shall approve a budget for the operation of the Association during the forthcoming year and submit such budget to the members for ratification pursuant to applicable law. Said budget shall include such items of expense as are determined from time to time by the Executive Board.
- 10.8 <u>Inspection of Records</u>. Any Owner or First Mortgagee may inspect the Association's records of receipts and expenditures at any reasonable time during convenient weekday business hours, and, upon fourteen (14) business days' notice to the Executive Board or

Manager, if any, and upon payment of a reasonable fee, not to exceed Twenty Dollars (\$20.00), any Owner or First Mortgagee shall be furnished a statement of account setting forth the amount of any unpaid assessments or other charges due and owing from such Owner.

- 10.9 <u>Captions</u>. The captions and headings in these Bylaws are for convenience only and shall not be considered in construing any provision of these Bylaws.
- 10.10 <u>Numbers and Genders</u>. Whenever used herein, unless the context shall otherwise provide, the singular number shall include the plural, the plural the singular, and the use of any gender shall include all genders.
