

15) Gordon Believes that Normal Rules and Boundaries Do Not Apply to Him. He is overly permissive and negligent

16) Gordon Uses Guilt, Threats, Brainwashing, Physical Force and Manipulation to Get Children/Youth to Do What He Wants and Think What He Wants

Dr. Victor Cline, who did a limited evaluation (Item 14a) stated, "I can certainly render an opinion based on 35 years of clinical practice as well as working many years with sexual addicts that . . . Mr. Bowen would appear to me to have reduced impulse control, gives evidence of being erratic in his behavior with sometimes poor social judgment, a long history of irresponsible behavior and highly probable sexual acting out which would be sufficient reason for the court to limit his association with his two children as being in their best interest as well as protect them from potential harm." Dr. Cline also wrote a letter, July 16, 2004 (Item 14b) in which he says, "In reviewing my previous "Limited Psychological Evaluation," of Mr. Bowen (10 May 2003) and in our discussions of April Braack's visitation reports (Item 1, 6 April Braack) would lead to my recommendation of Mr. Bowen receiving a psychiatric examination to evaluate his mental, sexual and emotional stability."

1) Gordon Displays Dangerous Delusional Thinking as Evidenced in His Journal and Enemy List and Conversations with Family and Associates. Gordon Views Himself as a "Savior" to Collin, Eric, Lily and Caleb, Having the "Voice of God," and Asserting Power Over the Children by Virtue of his Belief that he has this Special Relationship with "God" who tells him that he is full of evil spirits, yet a chosen son who must rescue all the children from Barbara, and that Eric has felt some sexual desire towards Gordon and needs hard, masculine love from him, that Barbara is full of evil spirits that Gordon gave her through intercourse. However, "God" also tells Gordon that he hurt "those beautiful boys" and their mother who trusted them.

a) A9, 42. Thom Harrison. "...Gordon's probable Dissociative Identity Disorder creates Gordon's report of hearing inner conversations and the voices of other personalities, which often comment on or address his family conflicts. These voices can be experienced as hallucinations. In Gordon's journals, he often becomes the voice of God, and this voice tells him to destroy Barbara and take no captives."

A17, 6. "Khaliel Kelly ...I also witnessed many attempts by Gordon to appear religious and generous but which upon further consideration were manipulative or dishonest or hypocritical...he seemed to have some sort of God complex, identifying himself with Deity."

When Gordon's aberrant homosexual lifestyle was being uncovered, he began seeing a therapist who specialized in casting out evil spirits, David Hamblin, who had lost his license for having had sex with his clients. Gordon also saw Melvin C. Fish, an

unlicensed therapist who also did intensive work casting evil spirits out of Gordon, taught him about the tools of Satan and Satanic abuse (Item 18a "Healing the Inner Self by Melvin C. Fish), and taught to keep a journal in which Gordon asks God a question and "God" answers. In 2003 and 2004, Gordon wrote over a hundred journal pages (Item 18b) with the following entry examples:

"You are a chosen son.. .You have been a conduit of evil spirits that are legion—not a few—but battalions sent to destroy your work and works. .. Your sins were foreordained...so you could **learn the secret combinations, words, ... signs, oaths, and songs...** Evil spirits are being weakened in their grasp as the impurities are being flushed from your system. You've got to resist evil and for you sugar attracts evil like a magnet. Get prepared for war with Satan.. .Barbara is his instrument now.. . **You can save these kids and you must. Lily is dying inside. Fight for her. Be a general and a soldier...**Barbara is wacked. . .She would kill you if she could. No one loves them enough to ride into the sins of hell to save them... You have to go with the angels of heaven and take on Satan himself. **Barbara needs to break to get well... You must begin to build a psychological profile of Barbara.**

(Gordon's voice: Lord, should I ask for custody.?) **You are going to have custody of the children when Barbara breaks down... Barbara will be in prison for killing the children. ..Plan the attack... Take no prisoners... This is Pearl Harbor.. . You must proceed with intelligence and cunning.. . Use everything you have learned in the biz to fight like you never have before... You need balls. In a humble context, you are an expert. It is my desire that you help heal Eric in the same way I have healed you. By casting out devils, unclean spirits... Eric needs you. Pray about him. Save him. You are the one who can. .. Eric needs hard masculine love from you.** He's asking for it. **He has also felt some sexual desire toward you** which confused him because he is not homosexual..., **all her boys are sexually wounded.** They came into life that way, genetically. Steve's (Timothy~ stuff in them.

Eric, he's got Steve B. (Boyce) in him. Literally. (Gordon's voice: Huh? Is Steve back here living thru Eric?) (spirit felt here)
Gordon, my son, I'm going to speak plainly here. You are their chance for redemption. You were sent here to do that.... because to be redeemed they need to heal the Timothy line and heal the Boyce line and heal their mother. You were sent to do that. You were under oath to powers of darkness for sure but they did not steal your agency.

Jesus did not earn his pain. He owned his mission. You need to own yours. ...look what you did to those beautiful boys. They wanted to love you. They trusted you. And believed you. And you hurt their mother and hurt them. Barbara tried to love you. Reached out. You shut her out. You shut down her heart. She was a tender spirit and a great great soul and you broke sacred covenants. **Over and over and over. Barbara is screaming, 'Put me in check. Give me parameters. My female raging waters are flooding the earth, and killing everything in their path. You must put me in granite channels of truth... Barbara is in open rebellion to me, but I will give her to you. Women are supposed to go to their men.'**

b) In Collin and Eric's affidavits, (A2, 16c, A3, 61, A4, 9i.k) they both state that while in

Gordon's apartment they have read journal entries of Gordon's writing in which he states that **"evil spirits are possessing his body and mind and causing him to act out in a homosexual manner."** Collin says, **"I have also had conversations with Gordon in which he has told me that he is convinced that his homosexuality and the struggle he has had with it is the result of some sort of evil presence that inhabits his body."** A4, 9i. Eric Boyce Timothy. Eric states, "In October 2003, Collin and I went back to New York for a short visit. During this trip, Gordon left his journal in plain sight and I noticed an entry where he had indicated that **"evil female spirits" had taken over his body and caused him to be homosexual**" 9k. On February 21, 2004, Gordon called me and asked me to meet with him to discuss my finances. In that meeting, **I told Gordon that I could not trust him and that he was a liar. I told him that it made me irate that he came into this marriage while living a homosexual life, but pretending to be something else.** Gordon told me that he had changed and was now only 10% homosexual. **He said that "healers" had helped him to see that he had two evil female spirits in his body that had caused his homosexuality,** that when they had been cast out he felt alive again, but that they had come back and he was having a hard time."

c) Summer 2003, Gordon hired **David Hamblin and Kisi Watkins** to fly back to New York where Collin and Eric were living with him in his \$14,000/month apartment to **interrogate and "brainwash" them in a three day process** in which they tried to psychologically diminish them, to convince them that they were flawed and that Gordon was a **"benevolent saint."** Gordon joined the process on the third day, stealing their passports and plane tickets for a U of U summer class in Europe and threatening to send them back to Salt Lake City and not allow them to finish their internships in New York City. Collin and Eric both said that they were psychologically held hostage for this terrifying process in which David told the boys that their mother was crazy, that God would be angry with her for making the serious mistake of divorcing Gordon, that their deceased father, Steven Timothy was a sexual deviant and that they were sexual deviants who had inherited this from their father. Gordon tried to convince them that they needed to get therapy from David and have the evil spirits in them **"cast out,"** that David was the only one who could really help them.
