

18. February 2000. While I wait in the lodge at Snowbird for the results of the in vitro, Gordon skis all day with Mitt and Ann Romney. When I tell him that I am pregnant, his reply is, "Oh, damn. I'll never get to see her." (He assumes it is a girl because I have told long before the procedure that I feel there is a little girl, followed by a little boy.)

18. April 2000. Gordon is fired from Idea Exchange, Salt Lake City internet business.

19. April 2000. Gordon moves to Boston to begin work with UPromise. Later, when Eric and I offer to move to Boston, Gordon discourages us.

20. August 1, 2000. Lily is born, 7 weeks premature, emergency c-section. (Gordon happens to be in Salt Lake City for a committee meeting for the Olympics. He stays for a day and then returns to Boston and apparently spends the next two weeks calling male prostitutes.) I have to find rides 3-4 times a day to take breast milk to feed Lily. I also prepare for a wedding, August 15, in our garden for my son Adam and his bride, Eva, and house her parents who have come from Bulgaria.

21. December 2000. Collin has found pictures of male escorts on Gordon's laptop. Gordon denies any knowledge of them and angrily says, "Is that what you think of me? Someone has borrowed my lap top and I'm going to take it to the office and have them tear it apart and find out who did this."

22. January 2001. I take a children's Literature class from psychologist, Hermann Peine and later do therapy with him. He writes a limited evaluation of the situation with Gordon.

23. Approximately March 2001, Gordon has sold his Yale Avenue home and Harvard Avenue home and together we purchase a 3.5 million dollar estate in Holladay on Haven Lane. We borrow money from my parents, take all the equity out of my home and get Bruce McMullin and later David Neeleman (JetBlue) invested in the property.

24. In April 2001, I move to Gordon's smaller Harvard home and rent it so Eric can finish up at East High. Gordon seldom visits, but when he does, he focuses on Lily for a few hours while I mop the floors, rake the leaves or shovel the snow. One evening as I am shoveling the snow, I go to the door and ask Gordon why he gets to play with Lily and I am left to do the work. He replies, "I work so hard all week, it is my privilege to play with Lily," and he shuts the door.

25. Spring 2002. One day while I am nursing Lily in the bedroom, Gordon walks in and says, "I am so jealous you get to nurse. I wish I had breasts. I wish I could nurse Lily through my penis or something." I am so stunned by the comment, I only say, "You are feminine enough without breasts." Gordon is so offended by this comment that he doesn't speak to me for three days until I apologize.

26. Summer 2001, Gordon takes Lily on two or three occasions by himself—shopping, to his mother's etc. After, I notice that she is beginning to have a preoccupation with her vagina, inserting her finger and other objects into it. I also observe a behavior that looks like masturbation where she crosses her legs, stiffens her body and makes a gyrating motion. I decide to not let Gordon take her alone again. But when we go to parties or family functions etc. Gordon always sequesters her by herself, e.g. upstairs in the toy room of a friend's house (Patty Johnson) while the adults are downstairs. Eventually, I call various therapists for help. They all tell me it is too difficult to tell if a child that young has been sexually abused.

27. February 2002. Gordon is involved has been involved in the Olympics. Collin comes home from his mission for a medical leave, serious problems with his back and ankles. We have a dinner and invite Gordon for a discussion concerning what Collin found on Gordon's laptop a year ago. Gordon talks in circles for three hours. Eric falls asleep. Gordon denies any problem with homosexuality, finally "admits" to a slight problem with pornography for the last 3 1/2 years. He leaves for L.A. and sends a letter to Collin the next day, apologizing and says he has "quit cold turkey."

28. We seldom see Gordon, but in March, he shows up one day and tells me he wants a divorce. The next day, (after staying overnight at the Grand American Hotel where he often goes with the excuse that his lap top doesn't work at our home—cell phone bills later reveal that he calls male prostitutes while there) he tells me he's changed his mind, wants to stay married, quit his job with UPromise and focus on the family.

29. August 2002. I undergo an in vitro fertility procedure for Caleb in Pasadena, California. Gordon refuses to join me for the procedure (cell phone bills later reveal he was calling male prostitutes in Salt Lake). Gordon comes after, gets his own hotel room and calls male prostitutes while he is watching Lily.

30. October 2002. Gordon moves to New York City and begins his own advertising agency, McGarryBowen.

31. October 2002. I make the decision to investigate Gordon and hire Dick Romano, Paramount Detective Agency. I have begun putting together Gordon's cell phone bills which show hundreds of calls to male prostitutes in every city he's been in, during all times of the day and times of the week. Also, I have been seeing Dan Gray who specializes in issues of homosexuality.

32. November 2002. I hire Rick Green as my attorney at Burt Dart's recommendation. I call about thirty of Gordon's former friends and associates. They individually confirm that Gordon is a liar, one of "The People of the Lie," "their closest encounter with evil," "Satan incarnate," "homosexual," "deeply dishonest," and recount numerous experiences to illustrate their feelings about him. Even though I am beginning to learn some of this, I am still in shock because I was wooed by a man who appeared, initially, to be so kind, spiritually-minded, and who convinced me that he loved me more than anyone on the earth, although soon after the marriage he began treating me with disdain, but always made me feel like it was my fault, that I was the problem.
33. December 17, 2002. My cervix effaces and I almost lose Caleb. Dr. Ware Branch sews up my cervix and puts me on a 4 month bed rest. The pregnancy becomes very complicated. Caleb has positioned himself in what is termed "an incarcerated uterus." I am eventually told that due to previous c-sections, they suspect I will experience an encrta (sp) where, as I understand it, the placenta will push through the uterine wall, causing loss of my uterus, possibly my bladder and, Dr. Branch tells me, even my life, having lost one patient with a similar situation.
34. Gordon has secluded himself to his life in New York. He has never been to a doctor appointment or concerned himself with any of the needs or the details of my life. For over six years, he has lived a separate life, showing up for the trip or the party or the holiday celebration, very non-communicative, blaming me or his work situation for his anger and depression. To date, I have probably spent over \$700,000 of my money trying to keep him in the lifestyle he demands. He refuses to work on the finances together, but always promises that he will soon be making huge amounts of money and will pay me back.
35. December 2002. Gordon begins seeing David Hamblin, his former psychologist who at this time has lost his license to practice, has been excommunicated from the LDS Church and, after his divorce, cannot see his children. (David's wife, Rosie hired Russ Hettinger in her divorce case. I later hire Russ Hettinger since he has a knowledge of this type of situation.) David specializes in casting out evil spirits. He works with my friends of 30 years, Kisi Watkins who does cranio-sacral therapy while David casts out the evil spirits. I have worked with David and Kisi in the past, but when I found out about David's bizarre situation, I discontinue going to them.
36. December 2002. Gordon comes home for two weeks. He has never been home for more than a couple of days at a time. He comes under the guise of wanting to help me since I am on bed rest, but he is allusive, secretive, hiding in the house trying to listen to conversations. Gordon gives me a divorce proposal, along with \$5000 of pearls, a provocative love letter and a letter which blames me for the marriage not working. The next day he takes back the divorce proposal. I spend hours talking with Gordon trying to ascertain the truth about his life. He speaks for hours in circles.
37. January 2003. I let Gordon know I intend to divorce him. He says that if I do, he will fight me for custody of the children.
38. January 2003. Gordon tells me that his father's friend sexually abused him while his father watched when Gordon was seven years old.
39. January 30, 2003. Gordon is excommunicated from the LDS Church. That night, he breaks into my storage locker in my garage and steals all the files I've accumulated on his financial, moral behavior, cell phone bills etc. The next morning, when I discover this, I call him but there is no reply. I call Kisi who has been talking with him that morning and she begins the conversation by saying, "You are so vicious. When Gordon told you'd he'd been sexually abused as a child, you told him you wished you'd never married him." I was stunned and told her that I never said that nor would that ever be that cruel to anyone. (The night Gordon told me about having been sexually abused I told him I was so sorry for his abuse. Earlier in the conversation, when I told Gordon I thought he was homosexual, which he vehemently denied, I said I wished I'd never married him, but it had nothing to do with him having been abused. The abuse only made me feel sorry for him and care for him more. But his subtle lie was very effective in making me sound so callous and uncaring. Kisi wouldn't believe me, my friend of 30 years, and I began experiencing Gordon's cleverness in shifting the focus off his victimizing behavior and instead crying he was a victim, characterizing me as the unloving and cruel victimizer. This was the first experience of hundreds like it in which he used subtle lies to exonerate himself and make me the bad person.
40. I finally reach Gordon and try to appeal to him to come home and talk. He leads me on through the morning, saying he'll return, but doesn't show up until about 6:00 p.m. By that time my condition with the incarcerated uterus has caused the urine to back up into my kidneys, threatening a miscarriage with Caleb. I am crawling to the door to go with the friend I've called, Jerilyn Radman, to take me to University Hospital. In a very casual voice, Gordon offers to take me to the hospital. I decline his offer. I am now very frightened of him. After they empty my bladder and the crisis is averted, I return home and ask Gordon if he has returned all the files (five boxes). He assures me he has. Gordon has read what many of his cohorts have had to say about him being a liar, a homosexual deviant, a predator, having molested them etc. and his only comment to me was, "I think they're all jealous of me." When I get up the next morning, only one box has been returned. I spend the next five weeks in conversations with Gordon over the phone requesting the files. He keeps lying and saying he has sent them, but he never has.
41. March 2003. I hire Russ Hettinger to handle some of the psychological aspects of the case including the David Hamblin issues. Sitting in Rick Green's office, over the phone I ask Gordon to find another place to stay when he comes to Salt Lake City, to return all the files and to give me a full financial disclosure.

42. March 2003. Gordon goes to many people to solicit their help in making me see that I must stay with him in the marriage—my parents, Brad and Pat Nygren, Rick and Linda Eyre, and Truman Madsen. He appeals to them by saying that he was sexually abused by his father's friend, while his father watched, that he has done nothing wrong but perhaps hire a few men to hold him and that I am cold-hearted and unforgiving.
43. April 15, 2003. Caleb is born, emergency, vertical c-section, major surgery, but without the complications anticipated. Gordon is not there for the birth. On Easter day, April 20, Collin picks me up from the hospital and brings me home. Gordon follows me into the house, yelling at me, "Where is Lily? I have an Easter egg hunt for her." He does not ask me how I am or even bother to look at the baby; he just frantically tries to find Lily who is on her way with the couple that I have had stay with her while I am in the hospital. When I get up for a moment and observe Lily, Collin and Eric opening about \$2000 of Easter presents, I comment that he has certainly outdone my little Easter egg hunt at the hospital. Gordon gets offended and leaves. I walk outside and stand at his car window for 20-30 minutes as I apologize for offending him but reiterate to him that there needs to be a divorce. Gordon's comment is that he is certain God has told him something different, that we are supposed to stay together.
44. May 2003. Victor Cline does a limited evaluation of Gordon based on testimonies by people who've had close association with Gordon, cell phone records, journals entries and other information about Gordon. In the end Dr. Cline says, "Not having interviewed or subjected Mr. Bowen to a thorough psychological evaluation, I do not think it appropriate for me to label him with a DSM IV diagnostic category. However, I can certainly render an opinion based on 35 years of clinical practice as well as working many years with sexual addicts that based on what evidence we do have that his children (ages 2 and a newborn) would be at risk to be in his care unsupervised beyond four hours and never at this young age overnight. Frequency of contact might be safely once every 2 to 4 weeks. Mrs. Bowen cited an instance where when she was in the hospital having the in vitro fertilization procedures, Mr. Bowen, while baby-sitting Lily, in a hotel room was making calls to male prostitute escort agencies. Mr. Bowen would appear to me to have reduced impulse control, gives evidence of being erratic in his behavior with sometimes poor social judgment, a long history of irresponsible behavior and highly probably sexual acting out which would be sufficient reason for the court to limit his association with his two children as being in their best interest as well as protect them from potential harm."
45. May 2003, Dr. Hermann Peine also does a limited evaluation with similar conclusions to Dr. Victor Cline.
46. June 2003. My sons, Collin and Eric are living with Gordon in his \$14,000/month apartment in New York, Eric working for Gordon's friend, Janene James, Collin working for Gordon's company. Gordon promises Collin \$10,000 but never pays him for this work. (Before Eric goes, I help him fill out his mission papers and try to help him prepare for a mission which he says he wants, but the lure of New York and Gordon's apartment and money are too much for him to turn down.) Gordon flies David Hamblin and Kisi Watkins to New York. They interrogate Collin and Eric and essentially tell them that their mother is crazy, Gordon has done nothing wrong, God does not want me to divorce Gordon, I have caused Gordon's excommunication by talking to the stake president, that Eric and Collin are immoral, sexually deviant and that they have inherited this from their deceased father who was a sexual pervert and had problems with voyeurism. Gordon appears on Sunday, affirms what they have said, steals their passports and airline tickets and threatens not to let them go on their U of U class to Europe with Hermann Peine which I have arranged
47. July 2003. Rick Green files the divorce papers.  
Gordon forges my signature on a \$100,000 note with Zion's Bank.
48. September 1, 2003. Gordon comes to pick up his things at my home and says:
1. He has lived a lie.
  2. He lied to my father prior to our marriage about his homosexual activity.
  3. He had had homosexual relationships throughout the marriage including homosexual male prostitutes and people he knew.
  4. He had struggled with knowing whether he was homosexual or bisexual and the good news was that he was not homosexual at the core.
  5. He was trying to stop the behavior but it was very hard.
  6. He knew David and Kisi had spoken with Collin and Eric, but had no idea what about or why Collin would not want to ever see David again (denying having been involved in any of the conversations which Collin attests he was on June 2, 2003)
  7. He confessed to having forged my signature on the \$100,000 note.
- I beg Gordon to quit going to my parents because it is causing a wedge in our relationship, stressing them and compromising my mother's health. Gordon replies coolly, "Maybe you're creating the wedge, Barbara." I then tell Gordon that if he doesn't stop going to my parents I will go to his father and his mother and tell them what he is saying about his father's sexual abuse to him and I will get support from them. Gordon again replies coolly, "Go right ahead."

39. September 2003. Eric moves home and attends U of U.

49. September 4, 2003. Gordon's father, Wes Bowen is found dead in his apartment. Gordon's brother, Scott tells me the physician who was called in after they found him said Wes died either Monday night or Tuesday morning.

50. September 12, 2003. Wes Bowen's funeral. Gordon had scheduled 10 days off work prior to his father's death.
51. September 22, 2003. Gordon pushes his way through the door of my home, grabs Lily and runs out into the driveway. I go after him and he later uses it against me saying I was physically abusive to him.
52. October 2003. While putting a bill in Gordon's brief case, I find a "to do" list for his father's funeral. It includes a list of his "enemies" including men he has molested, his sibling, my friends, my siblings, my mother and men he has done business with at the time he was purported to have missed an important meeting because he was tied to a bed.
53. October 2003. Rick Green says he has arranged with Gordon's attorney, James Faust, for Gordon to have therapy and refuses to send a runner to pick up the financial files we've been waiting for. We part ways. Russ Hettinger takes over the case. ✓
54. November 2003. At Bud Scalley's recommendation I hire Lisa Reading, former commissioner, from his firm.
55. November 26, 2003. Gordon is scheduled for psychological testing with Dr. Larry Beal through my attorney Russ Hettinger. We are leaving this day for California for Thanksgiving break. Gordon insists on following us to California and demands parent time with Lily. I cancel our trip and invite him to see Lily in Salt Lake and do his testing. He decides to go to Florida instead and insists that he now cannot change his plans and thus avoids the psychological testing.
56. December 2003. Eric is suffering from major depression, picked up for possession of marijuana, loses his license to drive. Begins plea abeyance program., drug testing, AA meetings, classes. He works with Dr. Grosser, then Dr. Gray head of adolescent psychiatry U of U. I drive him to all appointments, help him find a job, etc.
57. January 2004. Gordon has been seeing Mel Fish for therapy. Mel specializes in casting out evil spirits like David Hamblin.. He gets Gordon to write a journal asking God questions and letting God answer. Gordon's journals are later obtained for Thanksgiving 2003 and April 2004. Gordon's journal reflect delusional thinking as God tells him that he is Christ's warrior, that his sins were foreordained, that he will be taught the secret combinations and codes, that he must rescue Lily and Caleb and my sons from me because I am full of evil spirits that he gave me through intercourse, that only he can save this family, that Eric is sexually attracted to him, that my deceased brother, Steve Boyce, is inside Eric's body. — 2004

The following are excerpts from his journals, a few selected statements from hundreds of pages:

You are a chosen son. Your sins were foreordained before the world was. It's part of my plan to expose Satan's plan. You have been a conduit of evil spirits and unclean spirits that are legion—not few—but battalions sent to destroy your work and works. The evil spirit energy you have has blocked your core, so you could learn the codes, secret combinations, words, symbols, signs, oaths, covenants and songs. My son, my son. You have been under assault by Satan himself. You have from birth been targeted. You are not evil. My son, the timing is perfect for my miracle. Your mission and the plan. Your homosexual actions have been selfish and untrue. You are forgiven, nevertheless and I can bring about a mighty change in Barbara's heart. I am God. Barbara is in open rebellion against me, but she is not in control. My will is for Barbara to be with you. Women are supposed to go to their men. Barbara is controlled by evil spirits right now but you gave them to her through intercourse. There are ways still for me to reach her tho her heart is bound by evil spirits. Barbara is the gift of God to you—the perfect companion and one you were to do great things with. Barbara knows only a role as a victim. And victims need oppressors. You were the victimizer. Barbara opened her womb and her whole life to you. By choosing not to honor your marriage vows you created and sowed the seed for the destruction of your marriage. Barbara tried to love you. Reached out. You shut her out. You shut down her heart. She was a tender spirit and a great, great soul and you broke sacred covenants. Over and over and over. You have been chosen to free my daughter from the unclean spirits that possess her. For her sake and for the family. Barbara needs to break to get well. You are going to have custody of the children when Barbara breaks down. You need to make sure that all your legal ducks are in a row and that you are physically, emotionally and spiritually and financially able to care for all. You will heal this family as a patriarch. You must proceed with intelligence and cunning. Plan the attack. This is pearl harbor. Take no prisoners. Use everything you have learned in the biz to fight like you never have before. Make it the pitch of your life. You can save these kids and you must. Barbara is wacked. Barbara will be in prison for killing the children. Barbara would kill you if she could. Get prepared for war with Satan. He is trying to destroy you and your family. You must fight. Barbara is his instrument now. This is about Barbara and Lily and Caleb and the rest. You must claim your husband and father roles. Claim your kingdom. No one loves them enough to ride into the sins of hell to save them. You have to go with the angels of heaven and take on Satan himself. Lily is dying inside. Barbara is not well and she is making Lily sick. Fight for her. Eric needs hard, masculine love from you. Eric has also felt some sexual desire towards you. What they are being taught is that if you are sexually wounded you cannot be forgiven by religious and godly women which is really messing them up with god and women because all her boys are sexually wounded. They came into life that way genetically. Steve's (Timothy) stuff is in them. You are called to heal your family line, the Boyce line, the Timothy line and do a mission for my church.

58. January 27, 2004. Gordon is finally served divorce papers.

59. January 2004. Eric tears his ACL.
60. February 21, 2004. Gordon meets with me and Holladay Mayor, Dennis Webb. When asked, he says that he did call male prostitutes when I was doing the in vitro for Lily and adds, "But I can't remember whether or not they came." At this time, Gordon tells Eric that he is only 10 % homosexual but that three evil female spirits keep inhabiting his body and causing him to become homosexual again.
61. February 2004. Discovery begins.
62. April 2004, I meet with Dr. Bernard Grosser, head of psychiatry, U of U medical school, who examines materials I've collected about Gordon. He says Gordon must receive a psychiatric evaluation and says children should never be left alone with children. Reading through Gordon's journal Dr. Grosser states that Gordon is delusional and perhaps psychotic.
63. From October 2002- February 2004, I accommodated Gordon's requests for visitation in the home. (Detailed elsewhere)
64. March 27, 2004 to November 13, 2004, Gordon's visits to children are away from the home and supervised by April Braack and Juncal Tortosa who have both written affidavits describing his devious behavior. Gordon misrepresents himself, using inappropriate boundaries, lies concerning many of these visits. (detailed elsewhere)
65. July 2004. Dr. Victor Cline writes a follow-up letter emphasizing the need for Gordon to have a psychiatric examination to evaluate his mental, sexual and emotional stability. In reviewing Gordon's journals Dr. Cline also states to me personally that Gordon appears to be delusional and maybe even psychotic.
66. September 2004. Dr. Hermann Peine writes a follow-up letter in which he reiterates the need for "a comprehensive psychological evaluation of Mr. Bowen before visitation rights can be safely determined." Dr. Peine also states, "She (Barbara) is resolved to stand up to Mr. Bowen in protecting the safety of her children and her home. She pays a significant emotional price for each of their encounters because of the history of distortion, deception, and emotional abuse frequently utilized by her husband. His homosexual exploits may well have placed her at physical risk for HIV infection; however, it is the toxicity of his manipulations that are emotionally so damaging. She recently expressed that she felt her husband was potentially as dangerous to her as Mark Hacking was to his wife. Based on the history of the Bowen's relationship, Mrs. Bowen's fear for her well-being and the health of her children is clinically quite rational. His ability to wield power and influence has contained many abusive elements towards his wife. Mrs. Bowen clearly becomes physically and emotionally healed the less contact she or the children have with Mr. Bowen....The need for forthrightness on Mr. Bowen's part is clear, however, his pathology may continue to drive his need for vindication, control, an absolution of any past wrongs on his part. He demands people see the world and relationships his way. His actions have often been labeled as "evil" by many of his past associates. His wife has often been placed in a position of feeling true terror and fears for her safety and that of her children based on Mr. Bowen's past actions and what he has stated in his writings. Based in part on his obsessions, his goal has been to receive worship and adoration by those around him, and if they won't or fail to keep it up, he may attempt to destroy their reputation and disrupt their lives. Mrs. Bowen is the primary target in this group presently. Mr. Bowen has revealed having a personal relationship with and being directed by God. He feels he is a mouthpiece for the divine and this special relationship often absolves him of his wrongs."
67. August 2004. Psychologist, Thom Harrison, finishes a limited evaluation of Gordon. Thom saw Gordon and me for individual and marital therapy five years prior to this limited evaluation. During the time of this limited evaluation he had many sessions with me, Collin, Eric, and Lily. In his limited evaluation, Dr. Harrison recommends that:
1. Lily is not allowed to be with Gordon Bowen and visitation cease until Psychosexual, Psychiatric and Psychological evaluations are completed and recommendations are given that it is safe for her to be with him.
  2. If visitation is allowed, all visits with Gordon must be supervised at his expense by a licensed supervision agency or an adult chosen and agreed upon by both parties, visits should be limited in scope and be supervised at a confined professional setting.
  3. Gordon is ordered to attend and complete a parenting course, which teaches appropriate boundaries and parenting skills.
  4. Lily is seen by a child Psychologist and evaluated and treated for her self-stimulation and possible dissociative disorder. Johanna Mcmanimin Ph.D. is recommended. (Similar recommendations for limited visitation were given concerning Caleb.) Dr. Harrison also writes:
36. Gordon is dangerous to Barbara, his children and to himself. His associates write of his honing in on people's weaknesses, ingratiating himself to them, and then exploiting them for his own purposes.
37. Gordon is profoundly needy. He threatens, and intimidates his children to keep them near him and entices them with money. He sabotages relationships at work, home and in society. Gordon announces rather than discusses; he tells not asks. Gordon has a hidden agenda and controls his family with control over their money while he spends freely and lavishly on himself. It is always his feelings that are discussed, not his children's or Barbara's. Gordon is also very good at reading people so this allows him to manipulate them easily.
38. Gordon has far more than a same sex attraction to gay orientation. He uses his fantasy of what he thought Barbara was before their marriage, should or could be after her marriage to him, becoming wife and sexual partner, to
