#### A Note from the Pastor:

"My soul glorifies the Lord and my spirit rejoices in God my Savior, for he has been mindful of the humble state of his servant. From now on all generations will call me blessed, for the Mighty One has done great things for me—holy is his name.

His mercy extends to those who fear him, from generation to generation. He has performed mighty deeds with his arm; he has scattered those who are proud in their inmost thoughts. He has brought down rulers from their thrones but has lifted up the humble. He has filled the hungry with good things but has sent the rich away empty. He has helped his servant Israel, remembering to be merciful to Abraham and his descendants forever, just as he promised our ancestors." Luke 1:46-56

This scripture is known as the Magnificat. It is the song Mary, the mother of Jesus, sings during her pregnancy as she prepares for the birth of Jesus. Any expectant mother will tell you pregnancy is a time of preparation. Advent is our time of preparation for the celebration of the birth of Jesus and the return of Jesus.

The season of Advent is now here; it started November 27<sup>th</sup>. Advent is four weeks long; four weeks every year inviting us into a season of self-examination and preparation for Jesus' coming again. Four weeks that lead us to Christmas when we celebrate Almighty God becoming a mere human being in Jesus to be with us and save us; heal us and set us free. God, in Christ, entered the journey of a messy birth and childhood. Jesus walked into the discovery of his destiny of sacrifice and service, high adventure and humble faith, danger and rescue, and yes, of death and resurrection.

It's easy to miss the importance of Advent. Advent means "coming" and our God is a God who has come and, yes, keeps coming to us. Why does God keep coming? Isn't once enough? No. God keeps coming to us because God is invested in our ever-deepening spiritual encounter and conversion.

Our conversion is not a one-time event, though it does have a beginning. Our conversion is a process of growing, of turning from sin and self and toward God. It's a journey to life; of freedom through worship, giving, and service.

As you journey through Advent, where is God calling you to turn and grow? Make this holiday season special as you examine yourself and turn more and more to the One who came and keeps coming to and for you. One tool that may be of assistance is an Advent devotional. If you have not already done so, please pick up your devotional booklet and start a daily devotional reading practice during Advent.

May God richly bless you as you prepare for Christ's arrival. Happy Advent and Merry Christmas!



#### The perfect gift.


Through the Christmas Joy Offering, we reflect God's perfect gift to us, with generous support of church leaders among us – past, present, and future – who have pointed us to God.








# Twelve Days of Christmas Food Drive

#### Minutes Stated Meeting of Session University Community Presbyterian Church

#### November 17, 2022, 6:30 PM, Fellowship Hall

Moderator Rev. Richard Mauer opened the meeting with prayer at 6:30 pm.

Scripture and Devotion: Paula Long presented a devotion on giving thanks and gratefulness. Scriptures included Eph 5:19-20, Phil 4:6, Col 3:17.

Present: Rev. Rich Mauer (moderator), Patti Gallagher, Roger Smith, Paula Long, Muffie Durst, Janet Johnson, Jerry McBeath, Donita Lawhead (deacon), Doreen McNeill (Clerk).

**Absent:** Lois Hildenbrand CP

**Approval of Minutes:** Session Minutes of October, 2022 were **approved by unanimous consent**. November 6, 2022 Congregational Meeting Minutes were read and **considered ready for review & approval at the next congregational meeting**.

Notices were posted on outside doors for members to call to be allowed into the locked building to attend the session meeting. No comments from members were received.

The clerk read correspondence:

In addition to items in the written report, Clerk McNeill received a PCUSA document regarding biblical resolution to conflict. Correspondence was received from Presbytery that the Ministry Commission will consider our proposed contract with CP Lois Hildenbrand.

Finance Chair, Jerry McBeath discussed what he learned about the **Fairbanks Climate Action/Interfaith working group** grant mentioned in the Clerk's report. We have a new contractor lined up to replace windows in the office to save heat. The working group has approved extending the grant to summer 2023.

Pastor Lois's report was sent and read before the meeting. We commented on the impressive report, especially given her illness this month

Deacon Donita Lawhead read and discussed the deacons' report. Deacons were commended on their outstanding care and nurture of members.

#### **New Business:**

2023 Proposed Spending Plan. We received the year-to-date income and expenses, and the 2023 Proposed Spending Plan. It was noted that UCPC is 2 months behind in mortgage payments and about 2/3 behind in fair share and per capita pledges to support mission of our Presbytery and the wider Presbyterian Church USA. We will catch up on the mortgage payments, but will remain behind in fair share payments for 2022. We discussed ideas to decrease expenses and concern that we cannot afford moving expenses for a pastor. No motion was received to pass the 2023 spending plan, as we hope more pledges will be forthcoming to help cover expected expenses.

Mission Committee motion: address the homeless situation on our property. The motion was tabled to the January 2023 meeting. We desire a solution and mission committee was asked for specific solutions to be brought to session.

Hospitality and Membership Committee:

Motion from committee: Remove the names of the deceased members from UCPC rolls. Approved

Motion from committee: merge the Fellowship committee with Hospitality and Membership and rename it Membership and Hospitality Committee. Approved.

#### **Old Business**

We affirmed our email vote to send our proposed contract renewal with Lois to the Ministry Commission.

Interim Pastor Search update

#### Clerk's Correspondence Nov. 2022

**Borough Code Complaint.** As approved by session, Doreen sent a code complaint (regarding the activity and mess on Lutke Ave.) to the borough planning office on Oct. 31. On Nov. 10 she received a response. The borough will clean up the mess on Lutke Ave., after the snow melts. The borough cannot do anything about people hanging out and sleeping there if they are not doing anything illegal.

We were encouraged to document illegal activity, problems, and concerns with dates, times, and descriptions. Therefore, I am asking everyone on session & in the congregation to document illegal activity, including calling the troopers, if necessary, and to also let Doreen know of dates, times, activities.

**FYNDout Free Pregnancy Center** sent a flyer about an abortion healing event on Nov. 10<sup>th</sup>.

Fairbanks Climate Action/Interfaith working group follow up, grant/weatherization. Karen Pyne asked for a follow up on us of the the \$2,000 Office Window Replacement Grant that Pastor Neill applied for. David Rohwer had had a contractor lined up to do it in summer 2022, but come spring, the contractor would not return his repeated calls. Note: Later, Jerry McBeath talked to Karen Pyne, who says the group will extend the deadline to summer 2023.

- 3. The committee acknowledged receipt from the Presbyterian Fdn. of a 2023 income payment for the Josiah Knox Memorial Organ Fund (\$167.17).
- 4. The committee recommended to the Personnel Committee that the administrative assistant's hours be temporarily increased to accommodate additional training in QuickBooks.

The next committee meeting will be **December 12, 2022**.

Roger Smith closed in prayer at 6:15 p.m.

Hospitality and Membership Committee: Tuesday November 8, 2022 9am.
