1. SPC Cash is currently in the ING and his ETS is within 30 days. The situation which caused him to go into the ING has not been resolved, but it should be concluded in a few weeks if he is allowed to extend. If SPC Cash extends, which Rule would apply?

- a.** F
- b.** G
- c.** D
- d.** I
- e.** He does not qualify for extension

2. SGT Brody does not meet the body composition standards of AR 600-9. He is currently participating in a weight reduction program and making satisfactory progress. At his current ETS he will have 6 years of qualifying service for retirement. His waiver to extend was approved. Based on this information only, what is the maximum time SGT Brody can extend?

- a.** 1 month
- b.** 3 months
- c.** 12 months
- d.** 18 months
- e.** 24 months

3. Your commander wants to extend a Soldier beyond age 60. He asks you when this waiver request should be submitted to ensure adequate time for processing. What should you tell him?
