1. Earlier this month SGT Smith enlisted into the ARNG for a six-year PS enlistment bonus. He was DMOSQ when he enlisted. He wants to know when he will get his bonus. What should you tell him?
 - a. He will receive the bonus payment in one lump-sum.
 - b. The first 50% installment will be processed for payment upon enlistment into the ARNG. The final 50% installment will be processed on the sixth-year anniversary of the enlistment.
 - c. The first 50% installment will be processed for payment upon enlistment into the ARNG. The second 25% installment will be processed on the 3rd-year anniversary, and final 25% installment will be processed on the fifth-year anniversary of the enlistment.
