F. Hierarchy organizational chart - Sandy made the motion to adopt the chart and add it to the handbook. Brian second the motion. Motion passed by all in favor.

G. XOOM energy, Bri states a Columbia Gas supplier would like for the MMA to review their plan to reduce gas rates at the shop. The board passed on the offer.

- Water and dye testing to continue for several weeks

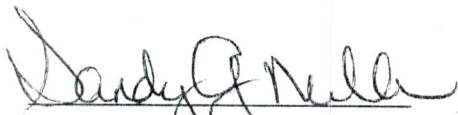
