### 2. OBLIGATIONS OF DISPATCHER

*DISPATCHER* agrees to handle paperwork, phone, fax calls to, from the *SHIPPER* to tender commodities shipments to *CARRIER* for transportation in interstate commerce by *CARRIER* between points and places within the scope of *CARRIER'S* operation authority.

*DISPATCHER* bears no financial or legal responsibility in transition between the *SHIPPER*, *CARRIER* agreement.

### **3. OBLIGATIONS OF CARRIER**

*CARRIER* agrees to pay *DISPATCHER* 10% for one truck **8%** for 2 trucks 3 or more truck will be **5%** of the contract between the shipper-carriers as stated on the load confirmation sheet.

*CARRIER* gives dispatcher authority to provide his/her signature for rate confirmation sheet, invoices, and associated paperwork, necessary for securing cargo and billing processing.

*CARRIER* shall have the sole and exclusive care, custody, and control of the *SHIPPER'S* property from the time it is picked up for transportation, until it is delivered to the destination, *CARRIER* assume the liability of a common carrier for loss, delay, damage to or destruction of all of shipper's goods or property while under *CARRIER'S* care.

*CARRIER* shall have the sole and exclusive care, custody, and control of the shipper's property from the time it is picked up for transportation, until it is delivered to the destination, *CARRIER* assume the liability of a common carrier for loss, delay, damage to or destruction of all of shipper's goods or property while under *CARRIER'S* care.

*CARRIER* agrees to hold *DISPATCHER* harmless from any liability for personal injury or property damage occurring during operation conducted by *CARRIER* pursuant to this agreement.

**PAYMENTS ARE DUE TO DISPATCHER FOR SERVICES RENDERED. PAYMENTS THAT ARE DUE TO DISPATCHER FOR SERVICES RENDERED ARE NOT CONTINGENT ON OUTSTANDING COMPANY PAYMENTS DUE TO CARRIER FOR LOADS THAT HE/SHE HAS HAULED FOR SHIPPER OR BROKER.**

**FAILURE TO PAY DISPATCHER FOR SERVICES RENDERED WILL RESULT IN TERMINATION OF CONTRACT AND SERVICES IMMEDIATELY UNLESS OTHERWISE DETERMINE BY DISPATCHER.**
