Red Rocks Country Club Fishing Permit Rules and Regulations 2021

We have a wonderful resource at Kingfisher Lake that current members and participating HOA members can use. This document outlines the process for fishing permits and what requirement will need to be met to be obtain a permit. Only current Red Rocks Country Club members in good standing and HOA eligible members are eligible to apply for FISHING permits.

1. Application:

- a. All members requesting a permit will need to submit an application packet containing the following items to be kept on file at RRCC:
 - i. Signed understanding of RRCC rules and regulations (this form)
 - ii. Names, Dates of Birth and address for all eligible family members that will be fishing. Must be living at this eligible address (next form)
 - iii. Permits will be issued for 1 calendar year and new applications will be need each following year

2. Rules and Regulations:

- a. All members/HOA fishing from land must display the RRCC permit while accessing the lake (Lanyard badge issued by RRCC)
- b. Minors fishing must be accompanied by an adult at all times. Minors under the age of 16 may NOT fish by themselves
- c. Permit members are responsible for reporting any unauthorized activity, violations, abuse of the lake or the surrounding park immediately to preserve a safe, pleasant and regulated amenity for Club and HOA members to enjoy
- d. No live bait will be allowed. Flies and lures only**
- e. All fishing is catch and release**
- f. Leaving waste of any kind in not acceptable
- g. No water contact, swimming or wading will be allowed
- h. Failure to comply with any of these rules will result in revocation of your permit and you will no longer have access to fish
- i. Hours/Seasons: Hours are from sun up to sun down. No Ice Fishing allowed!
- j. No guests will be allowed with HOA residents unless accompanied by a member
- k. No transferring of lanyards is permitted, ID may be required if questioned
- l. Discarded fishing line kills birds and other wildlife. All fishing permit holders are required to retrieve any discarded fishing line, hooks, and lures. Please keep our lake clean and safe for everyone.
