



For more than two decades, Jeff Campolongo has been singularly devoted to equal justice under the law. While Jeff's distinguished career has earned him several awards and accolades, it is his volunteer experience that shapes his vision for justice. In 2019, Jeff spent a week at the U.S./Mexico border as a volunteer attorney for The South Texas Pro Bono Asylum Representation Project. A year earlier, Mr. Campolongo was appointed as a volunteer attorney for the Center for Human Rights and Constitutional Law, assisting with reunifying separated children at the U.S. Border.

Jeff's scholarly work started in law school where he wrote for the *Delaware Journal of Corporate Law* law review. Jeff has continued this intellectual pursuit as a contributing author for the *Legal Intelligencer*, having published well over a hundred articles. Jeff also co-authored chapters for the *Pennsylvania Employment Law Deskbook*, an award-winning book written by some of the best employment lawyers in Pennsylvania. As a result of the coronavirus pandemic, Jeff was enlisted to provide *pro bono* assistance to nearly 500 childcare centers and day care providers through Public Citizens for Children and Youth (PCCY) in Philadelphia. To aid in that effort, he authored and published a free *Resource Guide for Small Businesses On Dealing With COVID-19*.

Jeff has demonstrated throughout his illustrious career that he would be an outstanding addition to the Montgomery County Court of Common Pleas.
