#### WILL I FIND WORK AFTER BEING QUALIFIED?

There is a lot of work in the UK and the majority being low level threat, however, that doesn't mean to say that as soon as you qualify and gain your SIA license you will walk straight into a position without putting any effort in.

## Due to the rise in crime rates, we are seeing a rise in close protection positions throughout the UK and not just in the main cities.

You will need to put the work in i.e., formulate a professional CV and cover letter. Add a head and shoulders photograph to your CV and attach a full length photograph in a suit or smart attire.

Build relations, network and communicate through various social media platforms as well as email or post your CV to security companies who specialise in providing close protection services.

As with any job, finding employment, whether it short or long term contracts takes effort. If you put in the effort it will pay off. If you are not willing to put in the effort then please do not take this any further.

#### DO YOU NEED TO HAVE A MILITARY BACKGROUND? NO

However it can be an advantage in some instances.

## DO YOU NEED TO HAVE A MARTIAL ARTS BACKGROUND? NO

However, a level of fitness is required.

#### DO I NEED TO BE BIG? NO

Often you will need to blend into your environment, be low key, be synonymous with that of your client, principal or VIP

In some areas of close protection such as the celebrity circuit being big may be a requirement.





#### **IS THERE A FITTNESS TEST?**

The SIA (Security Industry Authority) have not insisted that a fitness test or level of fitness be a requirement to obtain a close protection license to work in the UK, however, as a training provider we will require you to complete a health check questionnaire.

There are a number of companies that will ask you to attend an assessment day which will include fitness tests before they will employ or contract your services.

#### WILL A CRIMINAL RECORD CHECK BE CARRIED OUT?

Yes, everyone that applies for an SIA license will go through a DBS check. If you have a criminal record we advise you seek advice via the SIA website.

### **18 - DAY CLOSE PROTECTION OPERATIVE COURSE**

If you do not have a Door Supervisor qualification that includes Conflict Management and Physical Intervention you are required to attend the minimum duration of 18 days.

#### 18 Day Course Costs £1400

### **14 - DAY CLOSE PROTECTION OPERATIVE COURSE**

If you have a level 2 Door Supervisor qualification that includes Conflict Management and Physical Intervention you might qualify for a 14 day course by using Recognised Prior Learning (RPL). This is due to the Door Supervisor qualification now being a part of the complete Close Protection Operative course.

#### 14 Day Course Costs £1100

#### **6 - DAY CLOSE PROTECTION COURSE**

For those that have attended a Special Forces or Royal Military Police close protection course.

#### 6 Day Course Costs £700

#### PREREQUISITES:

Must be over the age of 18 years.

Must hold a First Aid qualification (minimum requirement First Aid at Work 3 Day) and have at least 12 months left on it at the beginning of the CP course.

You must also have in place the two Action Counters Terrorism (ACT) certificates that can be completed online.
