Empowering Tomorrow's Leaders

CEC sends students on a journey of history, leadership and connection

Each summer, Electric Cooperative Youth Tour gives high school juniors from rural communities a front-row seat to history and a hands-on introduction to leadership. From June 13–19, three outstanding young Oklahomans—Chloe Farley, Brooke Burrage and Ella Herron—represented Choctaw Electric Cooperative on this unforgettable journey to Washington, D.C.

Joined by more than 1,700 students from 45 states, the group explored iconic landmarks like the Lincoln Memorial, Arlington National Cemetery and the U.S. Capitol. One of the most powerful experiences was Capitol Hill Day, where students had the chance to meet with members of Oklahoma's

congressional delegation and learn how government decisions shape everyday life.

Youth Tour is about more than sight-seeing. It's designed to help students grow into informed, engaged citizens. Through leadership workshops and speakers who shared the cooperative story, participants were encouraged to think about how they can make a difference—at home and beyond.

Thanks to the support of local electric cooperatives, students like Chloe, Brooke and Ella return not only with great memories, but with a deeper understanding of democracy, public service and the power of rural voices.

Giving Back to Our Members

Choctaw Electric Cooperative returns \$2.3 million to members

I'm pleased to share some exciting news this month: Choctaw Electric Cooperative is retiring capital credits from the years 1999 through 2003. This retirement reflects both our strong financial position and our ongoing commitment to you, our members.

Capital credits are one of the most tangible benefits of co-op membership. Because CEC operates as a not-for-profit, any margins we earn are allocated back to our members based on electricity use. In our early years, these excess funds were reinvested to build and strengthen the cooperative. Today, thanks to a solid financial foundation and diversified revenue streams, we're able to return surplus margins to our members.

This year, we are retiring a total of \$2,307,360.98 in capital credits. Of that amount, \$1,960,986.08 remains unretired and will be distributed as checks to eligible members. The remainder was previously issued

through estate payments, honoring our pledge to serve members' families in a timely manner.

Approximately 16,674 checks will be mailed out, with an average check amount of \$117.60—nearly the value of a full month's electric bill for many members. This underscores the strength of your cooperative and the value of membership.

This capital credit retirement is possible thanks to careful financial planning and responsible governance

by our board of trustees. Each year, they work to ensure that returning margins to our members remains a top priority.

Eligible members can expect checks to arrive in September. We hope you'll also join us for Choctaw Electric Cooperative's Annual Meeting on Sept. 27. It's a great opportunity to stay informed, get involved and connect with your co-op community. We look forward to seeing you there!

How do capital credits work?

Because CEC is a not-for-profit electric cooperative, any excess revenues, called margins, are returned to members in the form of capital credits.

At the end of the year, CEC completes financial matters and determines whether there are excess revenues, called margins.



CEC allocates the margins to members as capital credits based upon their use of electricity during the year.

When CEC's financial condition permits, the board of trustees decides to retire, or pay, the capital credits.



CEC mails capital credits checks, with the amount based on a member's kWh of electricity used in the years being retired.
