
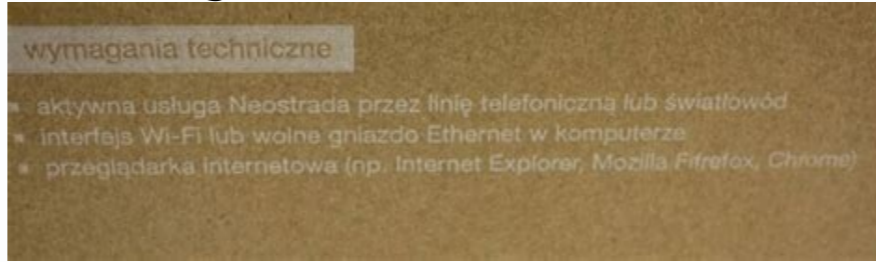

Safety and Certifications Important Information about the Sagemcom Fast 5250: Installation and Safe Usage Instructions: 1. Place the VDSL router in a vertical orientation on a flat surface. 2. Connect the manufacturer supplied AC to DC power adapter. The Fast 5250 router requires the use of a 12 VDC, 2500 mA power adapter. Only use a manufacturer supplied and approved power adapter. 3. Connect the Fast 5250 to the AC Mains in accordance with the installation instructions in this booklet, and the markings on the identification label (voltage, current, and frequency of electricity network). 4. Connect the Ethernet cable (provided) to one of the RJ45 ports on the VDSL Router labeled "LAN1", "LAN2", "LAN3", or "LAN4". Then connect the other end of the Ethernet Cable to the Ethernet port of a computer. Repeat as necessary for the other available Ethernet ports. 5. For an Ethernet WAN configuration, connect the RJ45 port labeled "WAN" to the connection provided by your ISP. 6. For a VDSL configuration, connect the provided DSL Cable to the port on the VDSL Router labeled "DSL1". Connect the other end of the DSL Cable to a standard Phone Jack. For a VDSL Bonding configuration, connect a second provided DSL Cable to the port on the VDSL Router labeled "DSL2". CAUTION: To reduce the risk of fire, always and only use a UL Listed or CSA Certified Telecommunication Line Cord (DSL cable) with a minimum wire gauge of 26AWG (0.4 mm dia. minimum, or 0.129 mm² minimum) or larger (e.g., 24AWG). 3. Connecting the F@ST3284 Gateway to Your Computer

Installation Procedure for Ethernet Interface

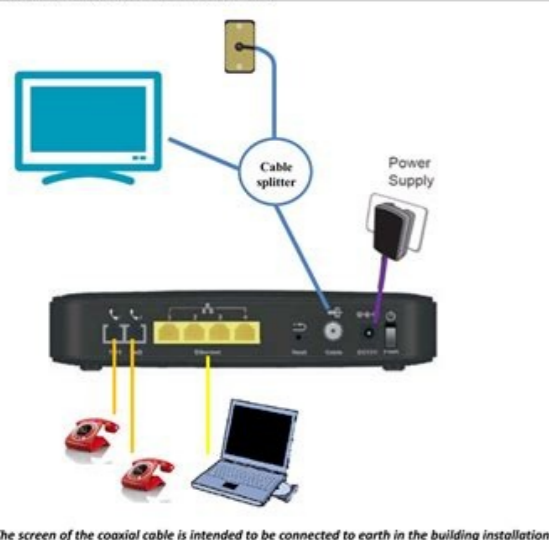
Follow the steps below for proper installation:

1. Make sure your computer meets the system requirements.
2. Connect a coaxial cable to the wall plug.
3. Connect a coaxial cable to the CABLE connector on the F@ST3284 and screw it at the bottom manually (do not force).

Note: To avoid any fire exposure process of F@ST3284, the coaxial cable should be connected to the gateway prior to the power connection.

4. Connect the RJ45 Ethernet cable to the ETHERNET connector on the gateway, connect the other end with the 10/100/1000BaseT Ethernet port on your computer.
5. Plug the RJ11 telephone cord(s) to the TEL1 or TEL2 connector(s) of the cable modem. (Plug the RJ11 telephone cord(s) to the PSTN connector on the modem, connect to the PSTN service provider. This step is for EXTA with PSTN model only.)
6. Plug the power supply unit into the POWER connector of the modem.
7. Plug the other end of the power supply unit into a power outlet.
8. Power ON the F@ST3284 by pressing the ON/OFF button on the rear panel of the F@ST3284.
9. The cable gateway will lock for the proper cable modem signal in the Cable Television network and process the initial registration. The cable gateway is ready for data transfer after the LED "ETHERNET" is in solid white. The gateway is ready to make a phone call after the LED "TEL1" or "TEL2" is in solid white.

Note: The BEZEL is fused to the rear panel for convenience purposes.



On the bottom side of this equipment is a label that contains, among other information, a product identifier in the format US:NS3DL01BFast5250. If requested, this number must be provided to the Telephone Company.
