

TOWN OF OAK GROVE, ALABAMA
ORDINANCE NO. 8M

AN ORDINANCE TO AMEND THE ZONING MAP OF THE TOWN OF OAK GROVE, ALABAMA AND ORDINANCE NO. 8, 8A, 008B, 8C, 8D, 8E, 8F, 8G, 8H, 8I, 8J, 8K, AND 8L, ENTITLED, "TOWN OF OAK GROVE ZONING ORDINANCE," ENACTED PURSUANT TO THE AUTHORITY GRANTED BY TITLE 11-52-70 THROUGH 84, INCLUSIVE OF THE CODE OF ALABAMA, 1975, AS AMENDED.

WHEREAS, the Town of Oak Grove Planning Commission has considered a petition for zoning, upon which a public hearing was duly conducted, and has submitted to the Town Council of the Town of Oak Grove a form written report and recommendation for action regarding said petition;

WHEREAS, the Town Council of the Town of Oak Grove has received a formal written report and recommendation from the Town of Oak Grove Planning Commission regarding a petition for zoning, and;

WHEREAS, all applicable requirements of the Oak Grove Zoning Ordinance and Title 11-52-77 of the Code of Alabama, 1975 as amended, have been satisfied,

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, ALABAMA, AS FOLLOWS;

Section 1. That Ordinance Nos. 8, 8A, 008B, 8C, 8D, 8E, 8F, 8G, 8H, 8I, 8J, 8K, and 8L entitled, "Oak Grove Zoning Ordinance" and The Zoning Map of the Town of Oak Grove, Alabama enacted pursuant to the authority granted by Title 11-52-70 through 84, Inclusive of the Code of Alabama, 1975, as amended, be and the same is hereby amended so as to zone the following described property, which is situated entirely within the corporate limits of the Town of Oak Grove, Alabama;

Those parcels annexed into the Town of Oak Grove on February 4, 2003 by Unanimous consent. Ordinance No. 54.

Section 2. That the above-described property is located as depicted on Attachment B (Map) and is further identified on attachment A (Tax Map No., Parcel Number, Tract Number and Property Owner(s)).

Section 3. That the above-described property is hereby zoned as depicted on the Map (Attachment B) which is hereby attached to this ordinance and made a part thereof, as the same is defined in said Oak Grove Zoning Ordinance, for purpose of the enabling said property to be devoted to such use(s) as is permitted under said Oak Grove Zoning Ordinance for the specific zoning districts shown on Attachment B Map.

Section 4. Except as herein amended, said Oak Grove Zoning Ordinance shall remain in full force and effect.

Section 5. This Ordinance shall take effect from and after five days from the date it is posted in accordance with Title 11-45-8 of the Code of Alabama, 1975, as amended.
