wasted, and purchased materials to possibly be unfit for use. \$20,000 worth of pipe was rejected. There is a possibility there may be a different project where it could be used.

<u>OLD BUSINESS</u> – Our annual Christmas dinner is scheduled for Dawndi's Restaurant on December 16 at 5:00 PM.

At the executive meeting in June, there was a discussion concerning whether it would be advantageous for the chapter to be incorporated with the Commonwealth of Pennsylvania. National TU advised us that there would be no real advantage as far as liability coverage. We are covered for liability under National TU. It was agreed not to pursue the matter.

Julie Thompson looked into whether we were eligible for money under the Cares Act. This is to aid organizations who have lost revenue due the Corona Virus situation. This can cover a loss of up to \$5000. We have applied, but the county currently has us on hold.

<u>NEW BUSINESS</u> – Dan Rockwell noted that Sheetz is no longer accepting checks, so we won't be able to offer Sheetz cards at our monthly drawings. The members agreed tonight that we will just have a choice of a gift card for the Neshannock Creek Fly Shop or a check for \$25 for the drawing at the meetings.
