

# The Civil War in March First Battle of Kernstown, March 23<sup>rd</sup> 1862



Although the battle was a tactical defeat for Stonewall Jackson, it represented a strategic victory for the South by preventing the Union from transferring forces from the Shenandoah Valley to reinforce the Peninsula Campaign against the Confederate capital.

### **Commander's Comments**

We had a marvelous February meeting. This marks the beginning of our 13th year having our meetings and suppers at Colonial Heritage Country Club. Dr. Eric Schweickert gave a very educational talk on the remains of the 4 soldiers found near the Williamsburg Powder Magazine. We hosted 30 guests, from all over eastern Virginia, who were very interested in learning about what the archaeologists have discovered.

We were joined by members of the Isle of Wight Avengers, the Dearing-Beauregard and the Lane-Armistead Camps of the SCV. Ladies from the Williamsburg, Petersburg, President Jefferson Davis and the Sally Thompkins Chapters of the UDC were attending. Representatives from the Williamsburg Battlefield Association, the Williamsburg Civil War Roundtable, and the Military Order of the Stars and Bars were present along with a variety of Williamsburg area residents.

On February 29th we received a letter from Jack Gary, Director of Archaeology at C.W., requesting our approval to proceed with DNA extraction. As the 'stakeholder' representing the S.C.V. and these presumed Confederate soldiers, we gave our approval. Preliminary osteological results from the William and Mary Institute of Historical Biology have allowed them to identify which of the 20 potential individuals most closely match each set of remains. The Virginia Department of Historical Resources and C.W. can now proceed and send these samples to the University of Connecticut Ancient DNA Laboratory. The goal is to complete the DNA extraction by March 12th.

### **Confederate Gravesites**

William Walker Ware (1803-1854) lived in James City County with his brother, Robert Ware and his family, for several years as a young adult. After his brother's death in 1828, William Ware continued to live with his brother's widow, Susannah, and her daughter, and they moved to Peach Park on Forge Road. The builder of Peach Park was William Walker, and looking at names, there may have been some kinship there. Susannah Ware eventually married Turner Christian of Charles City County.

William Walker Ware and Letitia Power Gregory were married on April 20, 1831, and they had five children. Their first two children were born in Charles City, so the family may have continued to live with or near Susannah and her new husband. Their second child, first son, Edmond Macon Ware, was born on July 10, 1834. W. W. Ware purchased 438 acres in James City County in 1835, and the family moved there. By 1851, the Ware family was living in the city of Williamsburg and the county land was sold by 1852. By 1854, Edmond Ware was living in Petersburg and working for a tobacco company. In the 1860 census, he was still living in Petersburg and his occupation was listed as "tobacconist."

Edmond Ware enlisted in the 3<sup>rd</sup> Virginia Cavalry in Williamsburg on June 24, 1861, and was elected 3<sup>rd</sup> Lieutenant in March 1862. He transferred to Company H, 5<sup>th</sup> Virginia Cavalry, on May 1, 1862. He was captured at White House on June 15<sup>th</sup> and sent to Fort Delaware. He was exchanged on August 5, 1862. Ware was appointed Captain and assistant Quartermaster on November 28, 1862. After signing for numerous supplies for the troops at a camp near Guinea Station in early January, he resigned from the cavalry at the end of January 1863.


He was reinstated in May as 3<sup>rd</sup> Lieutenant and detailed for Court Martial duty on May 25, 1863. He was company commander by November 12, 1863, and again, still as 3<sup>rd</sup> Lieutenant, he was listed as such at Orange Court House in February 1864. Edmond Ware was promoted to 2<sup>nd</sup> Lieutenant on May 9<sup>th</sup>. Ware was recommended for promotion to captain by General Lomax for "skill and valor" at Spotsylvania Court House on May 9<sup>th</sup> and at Yellow Tavern on May 11<sup>th</sup>. His promotion was approved by Gen. Fitzhugh Lee and Gen. Robert E. Lee. [Ware was also reported killed at Yellow Tavern.]

Edmond Ware was wounded in action in the side of his face, left thigh and left hand at Haw's Shop on May 27<sup>th</sup> and was admitted to a Richmond hospital on June 1<sup>st</sup>. He was promoted to 1<sup>st</sup> Lieutenant on June 16<sup>th</sup> and was furloughed for thirty days on July 14<sup>th</sup>. Ware was captured at Yorktown on the 19<sup>th</sup>, sent to Fortress Monroe and exchanged on August 18, 1864. He was finally promoted to Captain on September 9, 1864.

The October 1864 roll reported Ware "absent, wounded." In November, he was assigned to command Company E, Consolidated Regiment. After spending more time in a Richmond hospital from November 20, 1864 through January 1865, he was recommended for retirement for *Morbi Cutis* (skin disease), but he was detailed as an enrolling officer through February where his service record ended. Edmond Ware was paroled in Williamsburg on May 6, 1865.


### **Crosses of Honor**









