Compatriot Bill Miller President of the Williamsburg Civil War Roundtable

> "33 Days: Stonewall's 1862 Valley Campaign"



Bill Miller will give us insights tonight into one of the great campaigns in military history. Beginning on May 7, 1862, Stonewall Jackson and his small army will march & counter-march up and down the Shenandoah Valley defeating the armies of Fremont, Banks, & Shields in 5 key battles: McDowell (5-8), Front Royal (5-23), Winchester (5/25), Cross Keys (6/8) and Port Republic (6/9). He and his 'foot cavalry' became legend as the Union forces fled from these galloping ghosts.

Bill Miller regularly attends our camp meetings as a Friend of the SCV. He presently serves as the President of the Williamsburg Civil War Roundtable. Bill maintains memberships in numerous battlefield preservation organizations. Deo vindice

## **Confederate Gravesites**

Thomas Edward Evans and Juliet Littleton Upshur were married in Northampton County, Virginia in 1839. They had five children within the next ten years. About 1848/49, Evans purchased Cherry Hall farm from John H. Hankins. Located in York County, this farm had been owned by the Hankins family in the 18<sup>th</sup> century. The two story brick mansion house, an addition to the property, was built around 1837, before Evans acquired the farm. Unfortunately, this house which stood on the northern side of Lightfoot Road was demolished several years ago.

By 1850, this family was enumerated in the Bruton District of York County, Virginia. The birthplace for all five children was listed as Eastern Shore, so the family probably moved just after the youngest child was born. During the years that the Evans family lived there, Thomas acquired about 600 acres of land, part of which was in James City County, and was a very prosperous farmer. The Bruton District enumeration of the 1860 census is missing.

The older son, Littleton Upshur Evans, born about 1843, enlisted as a private in Company B (James City Artillery), 1<sup>st</sup> Virginia Artillery, on May 16, 1861, in Williamsburg. He was marked present on all rolls in 1861. On January 7, 1862, he was promoted to 4<sup>th</sup> Sergeant; on May 12<sup>th</sup>, 2nd Sergeant; and on June 4<sup>th</sup>, 1<sup>st</sup> Sergeant, and he re-enlisted for the war. Present throughout 1862, he was absent on December 28<sup>th</sup> on a surgeon's leave due to illness. He continued to be marked present on all rolls in 1863, and through August 1864. He received clothing on October 20, 1864, and his service record ended here. It is probable that he served until the end of the war and returned to the family farm afterwards.

Early in January 1863, Maj. William G. McCandless, 5<sup>th</sup> Pennsylvania Cavalry, dispatched two scouting parties from Williamsburg to sweep through the countryside as Confederate troops had been sighted approaching the town. One horse troop scoured the lower side of the York River and then turned west along present day Lightfoot Road to meet the main column at Six Mile Ordinary (present day Lightfoot). Thomas Evans and his family were occupying Cherry Hall when this troop passed by. No Confederates were sighted on this gallop out, but there were other confrontations reported in this area [*Picket Lines*, February, March 2020].

When the 1870 census was taken, the parents and all five of their children were living on the farm in the Bruton district. Thomas Evans, a farmer, owned \$6,000.00 in real-estate and \$150.00 in personal property, not small amounts for the times. Their post office was Rippon Hall, near the York River. Littleton Evans was farming with his father currently.

Again, in 1880, part of the York County census in missing which complicates this saga. Both the father, Thomas Edward Evans, and the son, Littleton Upshur Evans, are not found in the 1900 census. We do know that "the family" sold Cherry Hall to William Nelson Morris in 1881, which may be a clue that the father had died by that time. We do know that Juliet Upshur Evans died in 1896, and is buried in the James City Chapel Cemetery in Norge. In 1900, the other son, Thomas Edward Evans, Jr., his wife and five children were living in the Bruton District, very possibly on some of his father's other land holdings in the area. He and his wife and some of their children were eventually buried in the Chapel Cemetery

Like other veterans from our area, we know that Littleton Upshur Evans served in the James City Artillery, survived the war, and came home to farm with his father. However, we do not have a death date or burial site for him. Nevertheless, he needs to be remembered for serving the cause.

The Cavalry manned the Virginia Division Booth at the Virginia State Fair September 30. Despite heavy afternoon rain from Tropical Storm Ian we still sold over \$400 worth of merchandise and garnered the names of several individuals seeking to join a camp. 
