We continue our journey through time with Fred Boelt's Great-great uncle:

# **GREENMOUNT FARM JOURNAL**

We continue here with excerpts from Thomas Wynne's farm journal and his insights on the war locally in September 1861:

Monday, September 2nd... William and Moses returned home from Warwick where they have been employed, since last Tuesday week, on the fort on Mulberry Point.

Tuesday, September 3rd...Two men from the 14<sup>th</sup> Virginia Regiment, stationed at Land's End in Warwick Co., came by here this evening en route for Wmsburg and asked lodgings for the night. Wednesday, September 4<sup>th</sup>... Magruder sent again for my hands to work on the fort in Mulberry Island – Sent down Moses.

Thursday, September 5<sup>th</sup>...Hired out my wagon and mules for \$6 to a number of sick soldiers. Three sick soldiers stopped here tonight amongst them Mr. Picon of the 2<sup>nd</sup> La. Regiment. This regiment and the 15<sup>th</sup> Va. are ordered down to Cockletown [Grafton].

Saturday, September  $7^{th}$ ...Father and myself went down to Yorktown – 6 companies of the La. Regiment went below this morning – 4 companies of the  $10^{th}$  Georgia regiment camped out in my apple orchard late this afternoon on their way to Warwick Ct. House. Major Weems and Lt. Miller spent the night with me.

Monday, September 9<sup>th</sup>...Went down to Land's End with Ma [his mother-in-law, Elizabeth Curtis] – Two of the soldiers, belonging to the 14<sup>th</sup> Va. Regiment died there of Typhoid Fever. They had been kept out of ground so long that they smelled very offensive indeed. That portion of the regiment stationed here had been removed to Mulberry Island Point near Mr. Crafford's.

Tuesday, September 10<sup>th</sup>...Some of the soldiers from Williamsburg with beeves for Young's Mill stop here tonight. They sleep in my barn.

Wednesday, September 11<sup>th</sup>...Had two applications for carts to convey sick soldiers down to Young's Mill.

Saturday, September 14<sup>th</sup>...Went down to Yorktown today to deliver three of Dr. Fred Power's mules to Capt. Bloomfield, the Quartermaster to whom he had sold them for the Confederate States.

Wednesday, September 18<sup>th</sup>...Went down to Yorktown to collect some money due Ma from the Confederate States, but was unable to get it. This is the third time I have been on the same errand and so far have accomplished nothing.

Thursday, September19th...Went down, with Father [Richard Cary Wynne], to Mulberry to see the Quartermaster of the 14<sup>th</sup> Va. Regiment on business.

Friday, September 20<sup>th</sup>...A soldier of the 10<sup>th</sup> Georgia Regiment, who had been up to Williamsburg for the mail, stopped with us tonight.

Tuesday, September 24<sup>th</sup>...A soldier from the 5<sup>th</sup> La. Regiment came by tonight and requested lodgings – We took the weary man in.

Wednesday, September 25<sup>th</sup>...Went down to Mulberry Island Battery in company with father to get my money for work of hands on the fort for the month of August.

Thursday, September 26<sup>th</sup>...Mr. Schwabe paid us a visit this afternoon. He came down from Richmond yesterday where he is engaged in the Ordnance Department making a fulminating composition for percussion caps. He gets \$160 per month.

Friday, September 27<sup>th</sup>...Capt. Selden came by tonight to get out of the rain. He belongs to the Chas. City Cavalry where he has the commissary's office.

Saturday, September 28<sup>th</sup>...The papers give an account of another glorious victory by the Confederates at Lexington, Missouri.

Monday, September 30<sup>th</sup>...Received a check of \$76.12 from the Engineer Department for Ma for the work of her servants on the fort at Mulberry Island Point. *To be continued*.

### JAMES CITY COUNTY CONFEDERATE GRAVESITES by Fred Boelt

The Stonehouse Commerce Park on Barhamsville Road is located on a farm formerly known as La Grange. Early tax records show that the property was owned in the late 18<sup>th</sup> century by Edward Power and eventually by the Piggott, Taylor and Enos families. It has been said that Lafayette's troops were quartered there in 1781 and on his return tour in 1832, the Marquis de Lafayette visited there and the farm was then named after his estate in France.

Today, there is one gravestone located under the large pecan tree across the parking lot from the entrance door to the building at 3005 John Deere Road. This marks the grave of Eliza Billups, wife of the Reverend Humphrey Billups, a Methodist minister who served at the James City Chapel Methodist Church from time to time. Eliza was the sister of Warner Enos who owned La Grange at the time of her death in 1857.

So what does all of this have to do with the Confederacy? This is where oral history comes into play. Land records indicated that Warner Enos sold La Grange to a Dr. Jennings in 1861 and much later, the farm was sold to Littleberry Haley. In a conversation with Elizabeth Haley Glass who had grown up at La Grange, I asked her what she knew about the Billups grave. She remembered it well, but knew nothing about it, but she asked me if I knew that Dr. Jennings and his wife were buried nearby in unmarked graves? She said that one of the Jennings' grandsons had been a frequent visitor to her home and on many occasions, he had showed her where his grandparents were buried under a cedar tree about twenty feet from the Billups grave. The tree is now gone, but the hunt was on to complete the story.

Alvan James Edmund Jennings was born June 25, 1820 and eventually studied medicine. He married his first wife, Judith Edwards Vaiden, in 1850 and they had two children. After her untimely death, he married Virginia Hall Enos, daughter of Warner Enos, and they had one son. In 1861 Enos sold La Grange to his daughter and son-in-law. War erupted soon after this transaction, and Dr. Jennings enlisted in Company W, 3<sup>rd</sup> Virginia Cavalry on June 24, 1861 in Williamsburg and his occupation was listed as "Physician." He was listed as sick in July with no further record. However, he was listed on the post war roster for Company H, 5<sup>th</sup> Virginia Cavalry.

The family suffered losses to both the Confederate and Union armies. Dr. Jennings listed hogs and bacon taken by the Confederates as they retreated up the Peninsula in 1862 and he listed mules, sheep, cattle, fowl and a tumbrel cart and gear taken by Union soldiers between 1862 and 1864. He, himself, as a civilian, was held prisoner at Camp Hamilton near Fortress Monroe. Letters written by him to his wife in December 1864 and January 1865 assured her that he was all right but needed clothing. After the war, he listed twenty-one slaves that had belonged to him and six slaves that had belonged to his children that had been emancipated.

Dr. Jennings did not live long after the war, dying on January 19, 1868 at his residence, and was buried nearby. His wife died in 1897 and was buried beside him. Bible records, tax records, military records, wills and deeds provided a wealth of knowledge about Dr Jennings and his family. However, none of these told where he was buried. Without the oral history provided by Mrs. Glass, the final resting place of this Confederate veteran may never have been known.
