

October Guest Speaker

Navy Captain Robert Kennedy (Ret.)

"Damn the Torpedoes"



Capt. Kennedy will explore the development and employment of mines (aka torpedoes) and their role in the overall Confederate Naval strategy during the WBTS. The presentation will introduce organizational structure and key individuals who were responsible for the torpedo implementation program pursued by the Confederacy. Examples of the many mine types will be discussed, and finally, examples will be provided of the impact on the Union forces throughout the conflict.

If we are talking about letters or emails from a recent conflict in Iraq or Afghanistan, a hold can be placed on researchers using the letters for a given number of years so that the people discussed are no longer living. This is a very common consideration.

Over the years, we have honored the lives and service of many Confederate veterans from the Williamsburg/James City County area. There are still a few that need our memorializing.

Felix Pierce is one of these men. Based on census records, he was born about 1823. His mother was Elizabeth B. Pierce; father as yet undetermined. He had a brother, William F. Pierce, born about 1821, and they had an older brother, Robert B. Pierce, born about 1810. Without the father's name, we have not been able to determine where these men were born.

The 1850 census was the first census that listed all persons in each household. Felix Pierce was a 27-year-old farmer living in James City County. Also, in the household, there was his wife, Sarah E, age 33, and two sons, William M., age 4, and John O., age 1.

In the 1852 James City land tax records, Felix Pierce owned 130 acres adjacent to H. B. M. Richardson's Cloverdale farm off Ware Creek Road. Also, that year he purchased 235¼ acres from Thomas Taylor's estate. This land, roughly, extended from the Hankins land west of the present-day C&O Railroad right of way through present day Burnt Ordinary Apartments, on past the former Sheldon Lumber Company and the old canning factory. In 1857, Felix sold 5¼ acres to his brother, Robert B. Pierce.

In the 1860 census, Felix' wife Sarah was not included and perhaps had died by that time. His brother, Robert, his mother, Elizabeth, and his two sons were included in the household.

Older than the average inductee, Felix Pierce registered for service on April 1, 1861, at Burnt Ordinary. He mustered into service as a sergeant in Company I, 3rd Virginia Cavalry, on June 24th in Williamsburg. Present in July and August, he was on sick leave off and on during the fall and winter months. He was in the Episcopal Church Hospital with Diphtheria from February 27 until he returned to duty on May 4, 1862. By this time, he was in Company H, 5th Virginia Cavalry. In July, he was in St. Charles Hospital in Richmond.

After a gap in his records, by March 1863, Felix Pierce was employed as a nurse at Hanover Academy Hospital. In December 1863, he was transferred to Chimborazo Hospital for the same duty. His records end in August 1864, when he was still on staff at the hospital. Whether or not he served to the end of the war is unclear. He did return home to his farm in Burnt Ordinary

The 1870 census listed Felix and his second wife, Mattie F. Perhaps they were married late in the war years for they had two daughters, Beulah H. age 5, and Mattie E., age 1. Felix's older sons, William and John, were farming with their father. The Olive Branch Christian Church records indicate that Robert B. Pierce died in December 1865, and that Felix Pierce died on August 1, 1871. There is no indication that either of these men are buried at Olive Branch.

The older son, William M. Pierce, would have been old enough for service later in the war. In the 1896 newspaper article about the 5th Virginia Cavalry written by Col. Allen, he listed W. M. Pierce among the privates and indicated that he was alive. However, no service records have been found, and he was not listed in the 1900 census. The younger son, John O. Pierce was married and living in King William County in 1900.

We need to be on the lookout for Felix Pierce's grave.

9/8/25 Update – Baptist Hospital 1862 Remains

On September 8, Jack Gary, Director of Archaeology for Colonial Williamsburg, chaired an updating meeting of all the stakeholders to keep everyone appraised of the current developments. The four sets of remains have been interred at the Cedar Grove Cemetery in Williamsburg. The miscellaneous bones in the surgeon's pit have all been interred in a fifth plot. Now we are moving forward with the process of potential identification.

Evan Bell (Archaeology Department) and Elizabeth Drembus (William and Mary Bray Genealogy), based on data from prior osteological studies, have focused their attention on the most likely candidate to be in casket #3 and have done extensive work with military records and census records to work forward from 1862 to 2025 to determine the names of living relatives. The candidate had 9 sisters and brothers which allowed work on both maternal and paternal lines of DNA. Five generations down the maternal line (from a sister) there are 3 candidates. Three and four generations down the paternal line (from a brother) there are 4 candidates.

The Archaeological Department of Colonial Williamsburg will now reach out to the selected living ancestors of the soldier. Their goal will be to get their permission and DNA samples to run against the DNA they hold to confirm if this soldier is their great (4 or 5) uncle. There are many protections in place and after completion of the project the DNA samples will be destroyed. These samples will not be shared with other databases.

Dr. Raquel Fleskes of Dartmouth College's Ancient DNA Lab noted that they have excellent DNA from individual #3. Before burial additional DNA samples were taken from left and right canines on #1, #2, and #4 which resulted in improved DNA results for those remains.

With a group of several DNA strands from these relatives, Raquel will have 1 strand of maternal DNA and 4 strands of paternal DNA to compare with the DNA extracted from the skeletal remains of individual #3. If it matches, and they are hopeful, then the focus for individual #2 and individual #4 is more limited because logic dictates that their deaths were within a day or two of #3. If it does not match, then it will require a reset and re-evaluation.

None of this would have been possible without a small hospital, a surgeon who kept an excellent set of records, a small number of dead over a less than 2-week period, burial in shallow pits behind the hospital rather than a mass burial pit and the surprising condition of the remains which yielded viable DNA.

I have been out in Tennessee visiting family and enjoying historical sites. I have visited the SCV Headquarters and Museum, the battlefield at Franklin and the battlefield and the Rippavilla Plantation mansion at Spring Hill. Our SCV Museum continues to add displays. Their collection of weapons has grown significantly. They currently have on loan the original plaster cast for the death mask of Jefferson Davis. This cast was made immediately upon his death in 1889. Rippavilla was a very interesting site and upstairs they had two wonderful bronze busts of Confederate General Hood and Union General Schofield who were the opposing generals at both Spring Hill and at Franklin.

Commander Toalson in North Carolina

We were on the Emerald Isle as we headed north toward Ocracoke and Cape Hatteras. Fort Macon is at the northern end of the barrier island guarding access to Beaufort Harbor. It is owned by the State of North Carolina, and they have done a magnificent job of restoration. This masonry fort was completed in 1834. It has the inner citadel, a dry moat which can be flooded, and the outer bastion (as seen in the photo). They have created excellent displays on a wide variety of topics. The fort fell during the Burnside Expedition of 1862 after naval bombardment with rifled cannon. This is well worth a stop as long as the mosquito is not in season. It is free and they only seek donations to help with the purchase of guns, powder and ammunition for their artillery demonstrations.




