Mr. Michael Moore Lee Hall Curator

"Submarines, Infernal Machines, and Torpedoes"



The Civil War witnessed the successful deployment of many new inventions including the telegraph, balloons, mines, and submarines. Mr. Moore will present a discussion about the inventors and the technology that foreshadowed warfare in the twentieth century.

J. Michael Moore is the curator for Lee Hall Mansion and Endview Plantation. Mr. Moore received a BA in history from Christopher Newport University and a MA in history from Old Dominion University. During his tenure with the city, Moore has curated exhibits at several local historic sites. Moore has also co-authored two books and has served as the editor and photographic editor for numerous books and articles. In recognition of his work in public history, the Governor of Kentucky commissioned Moore a Kentucky Colonel in 2014. He is a Newport News native and resides in Historic Yorktown.



Envelope addressed to Mr. Dandridge W. Marston, Burnt Ordinary, Virginia

"My dear Sir,

Danville Apr 14th/64

I was truly gratified by the receipt of your kind letter of the 2nd instant and cannot adequately express to you my heartfelt appreciation of your constant and uniform friendship, which you have always shown to me whenever it was in your power to do me a service. The funding thru you of the \$600 by old Dick is one of the most remarkable events of this unhappy war and calls for the expression of praise and [I] send commendation to good old Dick which it is impossible for me to give that utterance to which he so richly deserves. You will please say to him however, that I shall never forget his honesty and trust, faith and devoted attachment to me, in the midst of the general desertion of those of his colour and that I shall always hold him as a true and faithful friend worthy of all confidence and trust. Give my best love to Dick and Milly and old Charles and old Jack and tell them that I really and truly respect and honour them for their firm and unfailing faithfulness. You did all that was right and proper in leaving the certificate at Aunt Betseys as it would most probably be safer there than at your house. As to the \$60 which you have applied to my credit on my bond, that too was right, except that the credit should be for \$30 or even less as the money has greatly depreciated. I sincerely deplore the suffering and losses to which you all have been so cruelly subjected by the enemy, but I hope and trust that you may be still able to bear up against your misfortunes until the end of your troubles comes and peace comes which I hope will not be long. First, I need request you to continue to have an eye to my poor old home and the faithful old negroes who have been so true to me; for I have every reason to know by past experience of your kindness, that you will still continue your friendly offices.

Remember me to all at Warrenton and tell Eliza Warren that I received her sweet letter, and will answer it in a few days. Please give my regards to Mr. George Hankins & family, and Mr. John Martin & family and Mr. Wilkinson & family & Mr. Branch & familyⁱ, also to Miss Betsey Pierce & family, and for yourself and your household the sincere regard of


In this second letter, also in a private collection, Littleton Waller was thanking his neighbor, Dandridge Marston for sending him \$600 earned by the formerly enslaved people still living at Lombardy. This is truly remarkable. The land owner has left them to fend for themselves with some oversight from a neighbor. They have continued to farm and have sent the proceeds from this venture to their former owner. The tone of the letter demonstrates Waller's admiration and respect for the older African American family still at Lombardy. Their loyalty seems to have been deep as witnessed by the money that they sent to him.

The letter in the last *Picket Lines*, written in 1862, was from Richmond. In this letter, Waller is living in Danville. One of the major challenges for those who refugeed was finding accommodations, room and board. As the war progressed, Richmond became more crowded so Waller may have moved south hoping for better quarters and provisions.




