## **November Guest Speaker**

Mr. Fred Taylor **Lawyer and Southern Patriot** 

"Through the Lens: History As Seen In **Period Images**"



The WBTS marks one of the earliest of wars to be documented on a wide-spread basis by the advent of photography. Tonight, Fred Taylor will provide an overview of early photography methods and image types, but also delve into individual images from his personal collection and how those images can launch research and preserve history.

It is guite possible that a photo of Thomas Mann, a man who was a pilot on more than 30 runs through the Cape Fear blockade, might be discussed. Perhaps some images of the Roanoke Minute Men of the 14th North Carolina could be in the program. Fred has collected more than 50 letters, new images, period and post war accounts and other minutia as he continues his research on this 'ongoing' book project. Those are just two guesses. You will have to come to the meeting and take a journey in personal photographic history.

Fred is a compatriot of the Tom Smith Camp in Suffolk. He holds a B.A. in History from O.D.U. and earned his law degree at Mercer. When not practicing law, he is following his love of history. He has been published in both Military Images and Civil War Navy Magazine.

### **Confederate Gravesites**

There are a number of men from the Williamsburg/ James City County area that served in the Confederate forces, survived the war years, but seem to have disappeared from the public eye later in life. One of these men was John T. Gilliam, step-father of Albert Crawley who was featured in an article in the June 2016 edition of *Picket Lines*. Albert's mother, Ann L. Crawley was widowed before the 1850 census was taken, but she had married John Gilliam by 1860. John was enumerated as a thirty-six year old waterman in that census. Ann's daughter, Sarah Victoria, and her son, Albert Crawley, were also living in the Gilliam household.

John Gilliam mustered into Company H, 32<sup>nd</sup> Virginia Infantry, under Captain Alexander H. Hankins at Burnt Ordinary on May 16, 1861. This company later became Company B,1<sup>st</sup> Virginia Artillery (James City Artillery). It will be recalled that Albert Crawley also enlisted in this company in 1863, when he came of age.

Gilliam was marked present on the July-August roll with a notation that he was in Seminary Hospital in Williamsburg from July 4-10, 1861. Seminary Hospital was located on the site of the Colonial Capitol at the east end of Duke of Gloucester Street. He was on leave on the December 1861 roll, and was furloughed on the December 1863 roll. Gilliam was marked AWOL on the February 1864 roll, and per Confederate records, he deserted on March 8, 1864. It appears that he actually took the oath at Fort Monroe on February 28, 1864, when he was described as having a sandy complexion, blue eyes, dark hair and standing five feet, seven and one-half inches tall, and he was a resident of James City County.


John eventually returned to James City County, and he and Ann were listed as residing there in the 1870 census, and John's occupation was "carpenter." Ann's older son, John Crawley, was also living in this household. John Gilliam was not included in the 1880 census, and it is assumed that he had died during the preceding decade. Ann was living alone in Williamsburg, and she was listed as a seamstress in the census. This is another example of a now unknown/believed unmarked grave of a Confederate soldier.

Another case of a soldier whose life is somewhat shrouded in mystery is that of Benjamin L. Lee. It has been said that he was from James City County, but he seems to have eluded the census taker. He did enlist in Williamsburg on May 16, 1861, in the unit that became the James City Artillery. He was sick at the Bigler's Mills Hospital in December. This was a small mill village located in York County and the site is in present day Camp Peary. In January and February 1862, he was at home on surgeon's leave. Again, he was admitted to Chimborazo Hospital on June 18, 1862, for "debility."

After that, Lee was present on the rolls until December 1863. He was then listed as being sick and sent to Petersburg General Hospital on December 3<sup>rd</sup>. He deserted while on furlough to the peninsula. He entered Federal lines in Williamsburg, and later took the oath at Fort Monroe on February 28, 1864. He was described as being light complected with blue eyes and brown hair. He was five feet, eight and three-quarter inches tall and a resident of James City County.

Benjamin Lee has not been found in census records after the war. Did he die before 1870? We write to honor the service of these men and hope that some of our readers may ultimately shed more light on their lives.


## **November Trivia Question**
