To be considered for participation in the TDOC/THDA Passport to Successful Reentry, Reentry Housing Program (RHP), I hereby agree to the following:

1. I understand that my participation in this program is voluntary and that I may choose to end my participation at any time.
2. I understand that the Tennessee Housing Development Agency (THDA) will, to the extent funding is available from the Tennessee Department of Correction (TDOC) therefor, pay up to a maximum of ninety (90) days of transitional housing assistance directly to the housing provider designated by the Tennessee Department of Corrections for my room and board so long as I comply with all requirements of RHP and of TDOC.
3. I will accept the housing and living arrangements made for me by TDOC.
4. Failure to accept housing and living arrangements made for me by TDOC will result in a termination of my eligibility to participate in the RHP.
5. I will continue to abide by all rules and conditions of my supervision in the manner prescribed by my Probation or Parole Certificate.
6. Violation of the rules and conditions of my Probation or Parole supervision may result in a termination of my eligibility to continue to participate in the RHP.
7. I will abide by the regulations governing the conduct of residents in the designated transitional housing provider program.
8. Failure to abide by the rules and regulations of the designated transitional housing provider may result in a loss of eligibility for continued RHP participation.

9. I may not change housing placement while participating in the RHP without written permission, obtained in advance, from my Probation or Parole Officer and his or her manager or supervisor.
10. I will complete the designated period for the transitional housing program. Early withdrawal from the program without permission will result in a loss of eligibility for future participation.
11. I may only participate in RHP once per period of Probation or Parole supervision.
12. I will diligently seek employment in a manner prescribed by the transitional housing program in conjunction with my Probation or Parole Officer. Failure to do so will result in my termination from continued participation in RHP.
13. I will immediately report any and all forms of employment I obtain to the transitional housing provider and my Probation or Parole Officer. Failure to do so will result in my termination from continued participation in RHP.
14. I acknowledge and agree that neither THDA nor TDOC shall be a party to any lease agreement signed by me. I acknowledge that all financial and other lease obligations are my responsibility, including, but not limited to, any property damage. I agree that neither THDA nor TDOC shall have any liability to me or any of my legal heirs or representatives for any matters connected in any way with my participation in the RHP, including without limitation, payment of any amounts to any persons for any reason.
